3	100% Federal funding of most costs under the Federal State Extended Benefits (EB) program currently is set to expire at the end of February. Without an extension, states that linked the expiration of their EB trigger to the termination of 100% federal sharing for EB will have their triggers end and will cease to be in an EB period. Absent additional state or Federal enactments, Alabama, Colorado, Delaware, Idaho, Indiana, Pennsylvania, South Carolina, Tennessee, Texas, and West Virginia triggered off of EB last week. The last payable week for these states will be the week ending February 27, 2010.
