<p>Based on the most recent unemployment data released by the Bureau of Labor Statistics on March 5, 2010, the seasonally-adjusted TUR for the 3-month period ending February 2010 for the Virgin Islands fell below the 6.0 percent threshold for a high unemployment period and will cause the Virgin Islands to conclude their payable period in the third tier of EUC effective March 27, 2010.
