Employment and Training Administration (ETA)

ETA conducted a review of the EUC and EB programs in Arkansas during the week of April 19, 2010.

The Dallas Regional Office conducted a Recovery Act Workforce Investment Act fiscal and program review in Tulsa, Oklahoma during the week of April 19, 2010.

On April 22, 2010, ETA conducted a webinar for the workforce system on the On-the-Job Training (OJT) National Emergency Grants (NEGs). On April 12, 2010, ETA published Training and Employment Notice (TEN) No. 38-09, *American Recovery and Reinvestment Act of 2009 On-the-Job Training National Emergency Grants,* notifying the workforce system of the availability of up to \$90 million in funding for OJT NEGs funded through the Recovery Act. ETA will also be releasing a Training and Employment Guidance Letter on the OJT NEGs.

On April 22, 2010, YouthBuild marked Earth Day with a Green Hands-On Construction Training for grantees, held in the Denver Joint Electrical Apprenticeship and Training Center's training facility. The Recovery Act provided \$50 million to expand and enhance YouthBuild nationwide as well as funding \$500 million in Green Job competitive grant opportunities, some of which went to YouthBuild sites.

The third round of Recovery Act Section 1512 Recipient Reporting began on April 1, 2010, for the period January 1 through March 31, 2010. ETA had 644 grantees scheduled to report through the FederalReporting.gov web portal by April 10. However, FederalReporting.gov experienced problems in operations on April 9 and as a result the reporting deadline was extended to April 16. ETA National and Regional office staff worked diligently to ensure all Recovery Act grantees submitted timely reports. As of midnight, April 16, 100% of ETA's grantees and contractors had reported for the quarter.

On April 15, 2010, the President signed into law the Continuing Extension Act of 2010 (P.L. 111-157). This act extended the Emergency Unemployment Compensation (EUC) and Federal Additional Compensation (FAC) programs, and the Federal funding of Extended Benefits (EB) provisions until June 2, 2010.

Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010. As a result, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB will soon have their triggers end and may soon cease to be in an EB period, even with the most recent extension.

Absent additional state or Federal enactments, the following changes will take place in the coming weeks: o The following states will have their TUR trigger expire on May 8, 2010 and have their EB payable period conclude on June 5, 2010: Alabama, Colorado, Delaware, Idaho, Indiana, Kentucky, Missouri, Ohio, Pennsylvania, South Carolina, Tennessee, Texas, and West Virginia.

o New York will have its TUR trigger expire on May 9, 2010 and have its EB payable period conclude on June 6, 2010.
o The following states will have their TUR trigger expire on May 15, 2010 and have their EB payable period conclude on June 12, 2010: Arizona, California, the District of Columbia, Georgia, Illinois, Maine, Nevada, Virginia, and Wisconsin.
o Massachusetts will have its TUR trigger expire on May 29, 2010 and have its EB payable period conclude on June 26, 2010.
o Michigan will have its TUR trigger expire on June 5, 2010 and have its EB payable period conclude on June 26, 2010.

Wisconsin began a 13-week mandatory "off" period in the Fourth Tier of EUC on January 10, 2010, which concluded April 10, 2010. With the recent extension of expiration dates for the EUC program, and the fact that Wisconsin's three-month average, seasonally adjusted TUR has been at or above 8.5% since the release of January TURs on March 10, 2010, Wisconsin is now eligible to return to payable status in the Fourth Tier of EUC and began its payable period as of April 11, 2010.

The Recovery Act provided for a special distribution of \$7 billion in Unemployment Compensation (UC) modernization incentive payments to states. To obtain its share, a state must make an application to the Department of Labor demonstrating that its UC law contains certain benefit eligibility provisions "to reflect the nature of the 21st century economy". As of April 12, 2010, \$2.8 billion has been distributed to a total of 32 states for UI Modernization incentive payments. ETA has actively encouraged states to apply for UI Modernization Grants, issuing TEN 27-09 -- Continued Availability of Unemployment Compensation Modernization Incentive Payments and conducting a peer-to-peer webinar. States have again begun applying for these grants. Applications are under review for Maryland's full share (100%), Utah's 1/3 share and Alaska's 2/3 share of UI Modernization incentive payments.


ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. As of April 9, 2010, 3,279 determinations have been made on cases received under the 2009 Amendments.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 215,500 since the enactment of the ARRA.

EBSA now has 63,000 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with 2,840,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 18,585.



Major Planned Actions (Short bulleted list of the major planned actions)

ETA's Atlanta Regional Office will conduct a regional review of Recovery Act, Labor Market Information and Migrant and Seasonal Farmworker activities in several Georgia local areas over the next two months.

The Boston Regional Office will begin the Connecticut consolidated compliance review, including Recovery Act activities, during the week of April 26, 2010. The review will combine a state review and two local area reviews.

The Atlanta Regional Office will convene a Discretionary Grantees Training Forum in Atlanta, Georgia from April 26-29, 2010. On April 25, a special one-day session on Green Jobs will precede the Forum.

On April 26, 2010, ETA will hold a Solicitation Grant Application (SGA) Day in collaboration with the Regions to provide technical assistance to Recovery Act High Growth and Emerging Industries (HGEI) grantees on performance reporting. Grantees are asked to view a recorded training session on performance reporting. These "SGA Days" are follow-up conference calls that are held between the grantees, Federal Project Officers, and ETA National Office representatives to answer questions and provide enhanced technical assistance.

The Boston Regional Office will conduct a combined EUC/EB review in Connecticut during the week of April 26-30, 2010.

The Chicago Regional Office will begin its comprehensive review of all ETA-funded programs, including Recovery Act programs, in Ohio. The review will take about six weeks to complete.

ETA will conduct financial management training Webinars for Recovery Act Green Jobs Competitive Grantees May 3-4, 2010.

The Chicago Regional Office will conduct a two-day YouthBuild learning exchange in Chicago on May 26-27, 2010. The event will provide an opportunity for grantee staff to learn green construction techniques and solar panel installation through hands-on exercises.

The San Francisco Regional Office is planning a Recovery Act Green Jobs/Health Care new grantee orientation for June 2010 in the San Francisco Bay area.

On April 21, 2010, an ETA Occasional Paper was released, *Pre-Design Study for the Evaluation of Recovery Act Green Jobs, Health care, and Other High Growth Competitive Grants.* The paper examines possible objectives of the evaluation of the Recovery Act grants and the most effective methodologies for the evaluation. A summary of the paper is available in Training and Employment Notice No. 40-09.
