Employment and Training Administration (ETA)

An exit conference with the Government Accountability Office (GAO) on their on-going Recovery Act implementation study was conducted on May 11, 2010. This study focuses on the WIA Dislocated Worker Program. ETA is submitting technical edits and comments on the GAO draft report. GAO will issue its final report on May 26, 2010.

ETA UI staff conducted a review of the EB program in Vermont during the week of May 10 and will conduct a similar review in North Carolina and Texas during the week of May 17.

The Philadelphia Regional Office hosted the "Trade's Got A New Attitude" Conference on May 11-12, 2010 in Philadelphia. The conference highlighted the changes made to the Trade Adjustment Assistance program in 2009 by the Recovery Act, and served as a follow up to last year's training. This conference was geared toward workforce development professionals, front line staff, and other stakeholders.

Per the Office of Management and Budget's (OMB) request, ETA has updated its Program-Specific Recovery Act Plans. ETA's updates were submitted to the Departmental Center for Program, Planning and Results on May 4, 2010 for clearance and submission to OMB by May 15, 2010. The Recovery Act Plans are published on Recovery.gov and the DOL Recovery page to demonstrate that individual program goals are being achieved.

The Emergency Unemployment Compensation (EUC) program, the Federal Additional Compensation (FAC) program, and Extended Benefits (EB) provisions begin to phase out on June 2, 2010. ETA will continue to monitor Congressional activities related to additional EUC extensions.

Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010. As a result, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB will soon have their triggers end and may soon cease to be in an EB period.

The Recovery Act provided for a special distribution of \$7 billion in Unemployment Insurance (UI) modernization incentive payments to states. On May 12, 2010, the Department of Labor certified for release \$20,332,402 in UI modernization incentive funds to the state of Utah, which qualified for a portion of its share of the funds available under the Recovery Act by updating its laws to allow workers to use recent earnings to qualify for benefits. On May 13, 2010, the Department of Labor certified for release \$10,412,823 in UI modernization incentive funds to the state of Alaska, which qualified for the remaining two-thirds of its share by extending unemployment benefits to individuals who leave jobs for compelling family reasons. Two applications are currently under review: South Dakota and New Mexico's 2/3 shares of UI Modernization incentive payments.

ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. As of May 7, 2010, 3,562 determinations have been made on cases received under the 2009 Amendments. Pending petitions under the 2009 Amendments have fallen below 1,000 for the first time since June 2009 and ETA continues to reduce this backlog weekly.

The Recovery Act-funded Health Care Virtual Career Platform Solicitation for Grant Applications closed on May 7, 2010.

The closing date for Recovery Act-funded National Emergency Grants On-the-Job Training (OJT) applications is May 24, 2010. The funds must be awarded by June 30, 2010.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 222,500 since the enactment of the ARRA.

EBSA now has 64,400 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with 2,955,000 total visitors since enactment of the ARRA.

Major Planned Actions (Short bulleted list of the major planned actions)

Congressional Testimony: Assistant Secretary Jane Oates is expected to testify on May 25 on Unemployment Insurance (UI) overpayments before the Senate Finance Committee. The Recovery Act has funded nearly \$50 billion in extended and expanded UI benefits since its passage on February, 17, 2009.

The Philadelphia Regional Office will conduct a comprehensive review of WIA and Wagner-Peyser programs, including Recovery Act, in the State of Maryland during the week of May 17-21, 2010.

The Philadelphia Regional Office will host the American Recovery and Reinvestment Act--A Year in Review: The Region, on May 25-26, 2010 for its quarterly Leadership Conference. State leadership and Partner Agencies representing Health and Human Services, Agriculture, Education, and HUD will also be in attendance. The meeting will focus on the successes and challenges of the enormous investment in the public workforce system as well as partnership opportunities. Wage and Hour and Occupational Safety and Health Administration will conduct presentations on laws specific to youth for local area providers of Summer Youth Employment Programs to ensure youth have a safe work experience.

The Chicago Regional Office will conduct a two-day YouthBuild learning exchange in Chicago on May 26-27, 2010. The event will provide an opportunity for grantee staff to learn green construction techniques and solar panel installation through hands-on exercises.

The Philadelphia Regional Office will convene the Reemployment NOW! Conference scheduled for June 8-9, 2010 in Philadelphia, PA. This event will provide the latest information available on economic changes, emerging industries and occupations and reemployment service strategies. The conference will target a diverse workforce development audience. Recovery Act contributions to expanding workforce services will be touched on in various sessions. A session on partnering with Temporary Assistance to Needy Families (TANF) will highlight practices in subsidized employment supported by Recovery Act Emergency Contingency funds awarded through the Administration for Children and Families.

The San Francisco Regional Office will hold a Recovery Act Green Jobs/Health Care new grantee orientation June 15-16, 2010 in the San Francisco Bay area.
