Congressional Testimony: Assistant Secretary Jane Oates testified on May 25, 2010 on Unemployment Insurance (UI) overpayments and UI integrity before the Senate Finance Committee. The Recovery Act has funded nearly \$50 billion in extended and expanded UI benefits since its passage on February, 17, 2009.	The Philadelphia Regional Office will convene the Reemployment NOW! Conference scheduled for June 8-9, 2010 in Philadelphia, PA. This event will provide the latest information available on economic changes, emerging industries and occupations and reemployment service strategies. The conference will target a diverse workforce development audience. Recovery Act contributions to expanding workforce services will be touched on in various sessions. A session on partnering with Temporary Assistance to Needy Families (TANF) will highlight practices in subsidized employment supported by Recovery Act Emergency Contingency funds awarded through the Administration for Children and Families	
On May 24, 2010, ETA National Office staff hosted a joint Webinar for all Recovery Act grantees to introduce them to ETA's industry competency models including career ladder/lattice tools. A follow-up Webinar will be held to explore in-depth application of these tools for interested grantees.	The San Francisco Regional Office will hold a Recovery Act Green Jobs/Health Care new grantee orientation June 15-16, 2010 in the San Francisco Bay area.	
ETA staff conducted a review of the Unemployment Insurance Extended Benefits program in Georgia during the week of May 24, 2010.	On May 27, 2010, the Department of Labor announced a \$1.75 million National Emergency Grant increment to the state of Wisconsin to continue to provide services to about 1,334 workers affected by layoffs at multiple companies, particularly in the manufacturing industry. This second and final increment is being awarded to the Wisconsin Department of Workforce Development. (On Aug. 5, 2009, a grant was awarded in the amount of \$3.4 million with \$1.67 million released initially, to serve about 1,227 affected by multiple layoffs and plant closures in northeastern Wisconsin. The grant was later modified to serve 1,334 workers in total.) This increment is being funded by resources made available for National Emergency Grants under the Recovery Act.	
The Philadelphia Regional Office hosted the American Recovery and Reinvestment ActA Year in Review: The Region on May		
25-26, 2010 for its quarterly Leadership Conference. State leadership and partner agencies representing Health and Human Services, Agriculture, Education, and HUD were in attendance. The meeting focused on the successes and challenges of the stimulus investments in the public workforce system as well as partnership opportunities. Wage and Hour and Occupational Safety and Health Administration conducted presentations on laws specific to youth for local area providers of Summer Youth Employment Programs to ensure youth have a safe work experience.  The Chicago Regional Office convened and conducted the DOL YouthBuild Learning Exchange in Chicago, IL, May 25-27, 2010. The event provided an opportunity for grantee staff to learn green construction techniques and solar panel installation through hands-on exercises. Workshop presenters included Federal Project Officers, Regional Office and National Office staff. Over 400 participants registered for the event. The Recovery Act provided \$50 million to fund new and existing YouthBuild programs nationwide.		
The Emergency Unemployment Compensation (EUC) program, the Federal Additional Compensation (FAC) program, and Extended Benefits (EB) provisions begin to phase out on June 2, 2010. ETA will continue to monitor Congressional activities		
related to additional EUC extensions.  Absent additional state or Federal enactments, the week ending May 29 is the last week of unemployment for which an individual may establish eligibility for EUC. Individuals exhausting a tier of EUC on this date may have their accounts augmented to the next higher tier.		
Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010. As a result, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB will soon have their triggers end and may soon cease to be		
in an EB period. Absent additional state or Federal enactments, the following changes will take place in the coming weeks:		
The following states will have their TUR trigger expire on May 8, 2010, and have their EB payable period conclude on June 5:		
Alabama, Colorado, Delaware, Florida, Idaho, Indiana, Kentucky, Missouri, Ohio, Pennsylvania, South Carolina, Tennessee,		
Texas, and West Virginia.		
• New York will have its TUR trigger expire on May 9, 2010, and have its EB payable period conclude on June 6.		
• The following states will have their TUR trigger expire on May 15, 2010, and have their EB payable period conclude on June 12:		
Arizona, California, the District of Columbia, Georgia, Illinois, Maine, Nevada, Virginia, and Wisconsin. NOTE: Georgia		
disagrees with our projected end date, and we are working with SOL to resolve this issue.		
• Nevada currently meets the Insured Unemployment Rate (IUR) trigger criteria to remain "on" in the EB program. Nevada's EB payable period will continue until it fails to meet the criteria to be triggered "on."		
Massachusetts will have its TUR trigger expire on May 29, 2010, and have its EB payable period conclude on June 26.		
• Michigan will have its TUR trigger expire on June 5, 2010, and have its EB payable period conclude on July 3.		
The Recovery Act provided for a special distribution of \$7 billion in Unemployment Insurance (UI) modernization incentive		
payments to states. One application is under review – Rhode Island's 1/3 share of UI Modernization incentive payments.  ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. As of May 7, 2010, 3,854 determinations have been made on		
cases received under the 2009 Amendments. The closing date for Recovery Act-funded National Emergency Grants On-the-Job Training (OJT) applications was May 24, 2010. Review of the applications began on May 25. The funds must be awarded by June 30.		
South Dakota's 2/3 share of UI modernization incentive payments was announced on May 26, 2010. The Department of Labor certified for release \$11.76 million in UI modernization incentive funds to South Dakota. South Dakota qualified for the remaining two-thirds of its share of the funds available under the Recovery Act by enabling certain part-time workers to be eligible for UI		
benefits and by providing additional weeks of benefits to people who are enrolled in training or education programs.  Employee Benefits Security Administration (EBSA)		

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been 227,000 since the enactment of the ARRA.	
EBSA now has 67,775 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with 3,015,000 total visitors since enactment of the ARRA.	
EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 19,971.
