ETA National Office staff members are finalizing a national On-the-Job Training (OJT) National Emergency Grant (NEG) Webinar for new grantees scheduled for July 8, 2010. They will also conduct an internal Webinar for Federal Project Officers on July 1, 2010.
3	On June 29, 2010, ETA hosted a webinar to provide an overview for the Recovery Act-funded High Growth and Emerging Industries (HGEI) grantees. Participants in this Webinar learned the key elements of today's Registered Apprenticeship system and how Registered Apprenticeship can partner with HGEI grantees to develop programs that are responsive to the needs of both workers and employers and lead to portable industry credentials.	The Philadelphia Regional Office has been working with the Commonwealth of Pennsylvania to replicate a successful all-state grantee roundtable hosted in Philadelphia at the Recovery Act Mid Year Review. On June 30, 2010, The Department of Labor announced a \$906,538 grant to assist about 400 dislocated workers who either are currently receiving intensive services and training from the state of New York or are on waiting lists for services and training due to funding shortages. Awarded to the New York State Department of Labor, this grant will be operated by 10 local workforce investment boards in the state. This grant will provide the state with additional funding to provide workers with access to dislocated worker services, such as skills assessment, basic skills training, individual career counseling and occupational skills training. This grant will be funded by resources made available for National Emergency Grants under the American Recovery and Reinvestment Act of 2009.
5	ETA staff provided technical assistance to Congressional and National Association of State Workforce Agencies (NASWA) staff on the implications of FAC expiring. Staff began drafting an Unemployment Insurance Program Letter (UIPL) for guidance to the states in the event that the FAC program is not extended.	On June 30, 2010, the Department of Labor announced a \$2.2 million National Emergency Grant supplemental award to provide an estimated 2,400 unemployed individuals in North Carolina with partial premium payments for health insurance coverage. The supplemental funds, awarded to the North Carolina Department of Commerce, Division of Employment and Training, will allow North Carolina to make "gap filler" payments for unemployed individuals who are receiving Trade Adjustment Assistance benefits and are eligible for the HCTC program. Under this program, eligible individuals can receive assistance with 80 percent of premium costs for qualified health insurance programs. This grant will be funded by resources made available for National Emergency Grants under the American Recovery and Reinvestment Act of 2009
6	Since the EUC law expired on June 2, 2010, the last date eligibility could be established for new participants was May 23, 2010.  Under the phase-out provisions, claimants may receive their remaining entitlement for the EUC tier in which they are collecting, but they may not advance to the next tier.	
7	Federal law currently provides for 100% Federal sharing for benefit costs under the Federal-State EB program for weeks of unemployment beginning before June 2, 2010. As a result, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB are ceasing to be in an EB period.  On June 18, the Bureau of Labor Statistics released new state TURs, resulting in the following:  • Vermont has triggered "off" EB. Vermont's 3-month average seasonally-adjusted TUR has decreased to 6.4%, which is below
