On July 22, 2010, the President signed the Unemployment Compensation Extension Act of 2010 (P.L. No. 111-205). With the exception of the Emergency Unemployment Compensation (EUC) "Fix," the provisions of the Act are retroactive, and there is no gap between the June 2, 2010, expiration date of the previous legislation and this Extension Act. All states have signed an addendum to the State Agreement that incorporates the new provision of the non-reduction rule, similar to the non-reduction rule in the state agreements for the FAC program. ETA staff completed the allotment of funds for payment of EUC and Extended Benefits (EB) retroactively to June 2, 2010.	
 Since Federal law currently provides for 100% Federal funding for sharable benefit costs under the federal-state EB program for unemployment beginning before November 30, 2010, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB will resume their EB periods. 	
• The following states that had their triggers expire resume their EB periods: Alabama, Arizona, California, Colorado, Delaware, the District of Columbia, Georgia, Idaho, Illinois, Indiana, Kentucky, Maine, Massachusetts, Michigan, Missouri, Nevada, New York, Ohio, Pennsylvania, South Carolina, Tennessee, Texas, Virginia, West Virginia and Wisconsin.	
• New Hampshire has triggered "off" of EB. It will conclude its payable period in the EB program on August 14 and will begin a mandatory 13-week "off" period.	
• Florida has extended its EB eligibility retroactively through an executive order that extends the duration of its EB trigger.	
New Mexico, New York and Wisconsin will trigger "off" of the Fourth Tier in the EUC program. The payable period in the Fourth Tier will conclude for New Mexico and Wisconsin on August 14, 2010, and for New York on August 15, 2010. The Recovery Act provided for a special distribution of \$7 billion in Unemployment Insurance (UI) Modernization incentive payments to states. An application was received on July 27, 2010 from the Virgin Islands for its 1/3 share of UI Modernization incentive payments. Applications are also pending for Rhode Island for its remaining 2/3rds share of UI Modernization incentive bavments and for South Carolina for its full share of incentive bavments. ETA will conduct reviews of the EB and EUC programs in South Carolina and of the EB program in Rhode Island during the week of August 2, 2010. ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. A total of 4,480 determinations have been issued on cases received under the 2009 Amendments.
