2	On August 20, 2010, the Healthcare Virtual Career Platform grantee lead staff from the American Association of Community Colleges met with Assistant Secretary Jane Oates and relevant ETA staff to discuss the goals and expectations for this project as a prototype effort for demonstrating new and innovative approaches to leveraging the power of Internet 2.0 to promote career exploration and training.	On August 23, 2010, ETA Atlanta Regional staff will participate at the Atlanta Federal Recovery Act Interagency meeting with Senator Nelson in Pasco County, Florida.
3	The Recovery Act made a total of \$7 billion in Unemployment Insurance (UI) modernization incentive payments available to states that include certain eligibility provisions in their programs. Each state can qualify for a share of those funds by showing that its law includes those provisions. On August 19, 2010, the Department of Labor certified for release \$667,637 in UI modernization incentive funds to the U.S. Virgin Islands. The Virgin Islands qualified for a portion of the territory's share of the funds available under the Recovery Act by updating its unemployment law to allow workers to use recent earnings to qualify for benefits. The Virgin Islands can use the funds to pay unemployment benefits or, if appropriated by the legislature, to administer its UI program or deliver employment services.	
4	Since Federal law currently provides for 100% Federal funding for sharable benefit costs under the federal-state Extended Benefits (EB) program for unemployment beginning before November 30, 2010, states that have linked the expiration of their EB Total Unemployment Rate (TUR) trigger to the termination of 100% Federal sharing for EB resumed their EB periods. New Hampshire has triggered "off" of EB. It concluded its payable period in the EB program and began a mandatory 13-week "off" period on August 14, 2010.	
5	New Mexico, New York, and Wisconsin triggered "off" of the Fourth Tier in the Emergency Unemployment Compensation (EUC) program. The payable period in the Fourth Tier concluded for New Mexico and Wisconsin on August 14, 2010, and for New York on August 15, 2010.	
6	ETA will conduct reviews of the EB and EUC programs in Alabama during the week of August 23, 2010.	
7	ETA Regional Office staff were on site in Vermont the week of August 16, 2010, conducting a Recovery Act review of the state's On-the-Job Training program.	
8	ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance amendments mandated in the Recovery Act which took effect on May 18, 2009. A total of 4,648 determinations have been issued on cases received under the 2009 Amendments.	
9	ETA National and Regional Office staff developed milestones and "points of celebration" for a list of 10 "Best Projects" that will be a part of a master list of government-wide Best Recovery Act Projects. Three of the above "Best Projects" have been selected as part of a report entitled "Great Projects" by the Recovery Act and will be prominently showcased in an upcoming release from the Recovery Implementation and Vice President's Office.
