On December 29, 2010, President Obama signed into law the Omnibus Trade Act of 2010, which included a six week extension of the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act — without this legislation, TAA entitlements under the 2009 amendments would have expired December 31, 2010. Under this bill, Trade Adjustment Assistance certification requirements under the 2009 amendments will continue to apply until February 12, 2011. To date, a total of 5,738 determinations have been issued on cases received under the 2009 Amendments.
