On September 28-29, 2004, Marcia Clark of the Western Regional Team, School Participation Team - San Francisco, conducted a focused program review of Saint Mary's College of California's administration of the Campus Security Act of Title IV Federal Student Aid Programs.

The review consisted of, but was not limited to, an examination of the institution's administration of the Campus Security Act covered under the Code of Federal Regulations, CFR 668.41 and 668.46, and Disclosures covered under CFR 99.31 including:

1. Annual Security Report - Contents
  - a. Crime Statistics
  - b. Campus Security Authority
  - c. Policy Statements
2. Submission and Distribution of Annual Security Report
3. Campus Crime Policies and Procedures
4. Data Sources
  - a. Institution Offices that support/disclose crime statistics
  - b. Campus Police/Security Department Operations, Policies and Procedures
  - c. Coordination with Local Police

Although the review was thorough, it cannot be assumed to be all-inclusive. The absence of statements in the report concerning the institution's specific practices and procedures must not be construed as acceptance, approval or endorsement of those practices and procedures. Furthermore, it does not relieve the institution of its obligations to comply with all statutory and regulatory provisions governing the Title IV programs.

There were no findings of non-compliance.
