 - (o) Children's bicycles (heading 8712);
 - (p) Sports craft such as canoes and skiffs (chapter 89), or their means of propulsion (chapter 44 for such articles made of wood);
 - (q) Spectacles, goggles or the like, for sports or outdoor games (heading 9004);
 - (r) Decoy calls or whistles (heading 9208);
 - (s) Arms or other articles of chapter 93;
 - (t) Electric garlands of all kinds (heading 9405); or
 - (u) Racket strings, tents or other camping goods, or gloves (classified according to their constituent material).
