LICENSEE: Exelon Generation Company, LLC (Exelon)  
FACILITY: Peach Bottom Atomic Power Station Units 2 and 3  
SUBJECT: SUMMARY OF MEETING BETWEEN THE U.S. NUCLEAR REGULATORY COMMISSION (NRC) STAFF AND EXELON REPRESENTATIVES TO DISCUSS THE PEACH BOTTOM LICENSE RENEWAL APPLICATION

On August 14, 2001, the NRC staff met with members of Exelon in a public meeting to discuss the license renewal application for Peach Bottom Units 2 and 3. The list of attendees is provided in Attachment 1. Also attached are the meeting agenda (Attachment 2) and handouts provided by the applicant during the meeting (Attachment 3).

Exelon demonstrated how information can be found on the CD-ROM version of the application. They discussed the scoping and screening methodology, and showed examples of system boundary drawings. Questions on scoping and screening methodology centered upon differences between Hatch and Peach Bottom, especially regarding resolution of open issues on Hatch.

Scoping and screening results for mechanical systems, electrical systems, and structures were discussed. Technical issues were identified regarding electrical system scoping and screening results that require a follow-up meeting.

The meeting included a discussion on existing, enhanced, and new aging management programs and activities. Questions on several of the aging management programs and activities focused on the absence of one time inspections based on Peach Bottom plant conditions and operating experience.

The applicant also discussed time-limited aging analyses such as environmental qualification and fatigue management. Questions centered on resolution of open issues on Hatch that were not incorporated due to timing of the submittal of the Peach Bottom application.

Argonne National Laboratory representatives, the contractor for the review of the application, also participated in the discussion by telephone. The introduction and discussion on the Peach Bottom License Renewal Application will facilitate the review of the application by the responsible staff and contractors.
