**Project Name: Vehicle Detection System**

(TIP ID#3216) Title: Traffic Operations Improvement Citywide (p. Vehicle Detection Station)

Estimated ARRA amount: \$4,700,000.00

Estimated total Cost: \$4,700,000.00

Location: Various locations, city wide

Description of Work: Project implements numerous citywide detection systems. These systems will determine the number of vehicles passing through various permanent count stations, occupancy, speed and classification of vehicle.

**Project Name: Sherman Ave. NW, Park Road to Florida Ave.**

(TIP ID#5308) Title: Neighborhood Streetscape Improvements (f. Sherman Ave., NW, Park Rd. – Florida Ave)

Estimated ARRA amount: \$2,600,000.00

Estimated total Cost: \$9,000,000.00

Location: Sherman Ave. NW, Park Road to Florida Ave.

Description of Work: Rehabilitation of Sherman Avenue N.W., From Florida Avenue to Park Road. Reconfiguration of roadway, widening sidewalk, relocation and upgrading traffic signals, upgrading street lights, construction of new median, planting trees in the median and in the sidewalk area.

**Project Name: Great Streets - Nannie Helen Burroughs**

(TIP ID#2959) Title: Great Streets – Nannie Helen Burroughs

Estimated ARRA amount: \$10,000,000.00

Estimated total Cost: \$13,000,000.00

Location: Nannie Helen Burroughs Ave, Eastern Ave. to Minnesota Ave.

Description of Work: Proposing several types of LID techniques along the corridor (bioretention swales, and water quality catch basins) Upgrading the Streetlight, Traffic Signals, and improving pedestrian and non-vehicular movement while still maintaining traffic and enhancing the community. Construct improvements to sidewalks, curbs, gutters, streets, tree boxes, replace street trees and install other streetscape elements. Construct facilities to improve reliability and safety of transit services, including transit lanes, provide bicycle lanes and improve pedestrian circulation. Improve the quality of storm water run-off before it enters the storm sewer and Watts Branch

Justification: These projects are for additional transportation infrastructure investments. As the DC Department of Transportation (DDOT) continues to amend the STIP and TIP to include projects funded by ARRA Transportation funds, the state will submit additional Section 1511 Certifications. These projects are federally eligible, have no right of way or design issues and can be bid quickly.
