**Project Name:** Contract 30-090-01, I-95 Newark Toll Plaza-Transportation Management Improvement Project

**Description of Work:** Re-striping, re-signing, signal modifications, and turn lane extensions/improvements.

**Cost:** \$2.5 million

**Locations:** Intersection of SR 896 and Old Baltimore Pike, Intersection of SR 4 and SR 896, and the Intersection of Otts Chapel Road and SR 2/Elkton Road.

**Justification:**

Federal regulations require that a Traffic Management Plan (TMP) be prepared for projects that occur on the Interstate. A TMP was prepared for Contract 29-090-02, I-95 Toll Plaza Highway Speed EZ Pass Lanes. The TMP recommended improvements on various roadways in close proximity to the Newark toll plaza to help minimize congestion during the construction.

This project was identified as federally eligible, has no right of way or design issues and can be bid quickly. This project will be bid in advance of the toll plaza replacement so that the improvements will be in place once the toll plaza construction begins.

The cost for this contract was included in the \$48.44 million listed in the current STIP and since it is mitigation for a project that was already approved in the STIP, this new project does not require a STIP amendment or modification as confirmed by FHWA.
