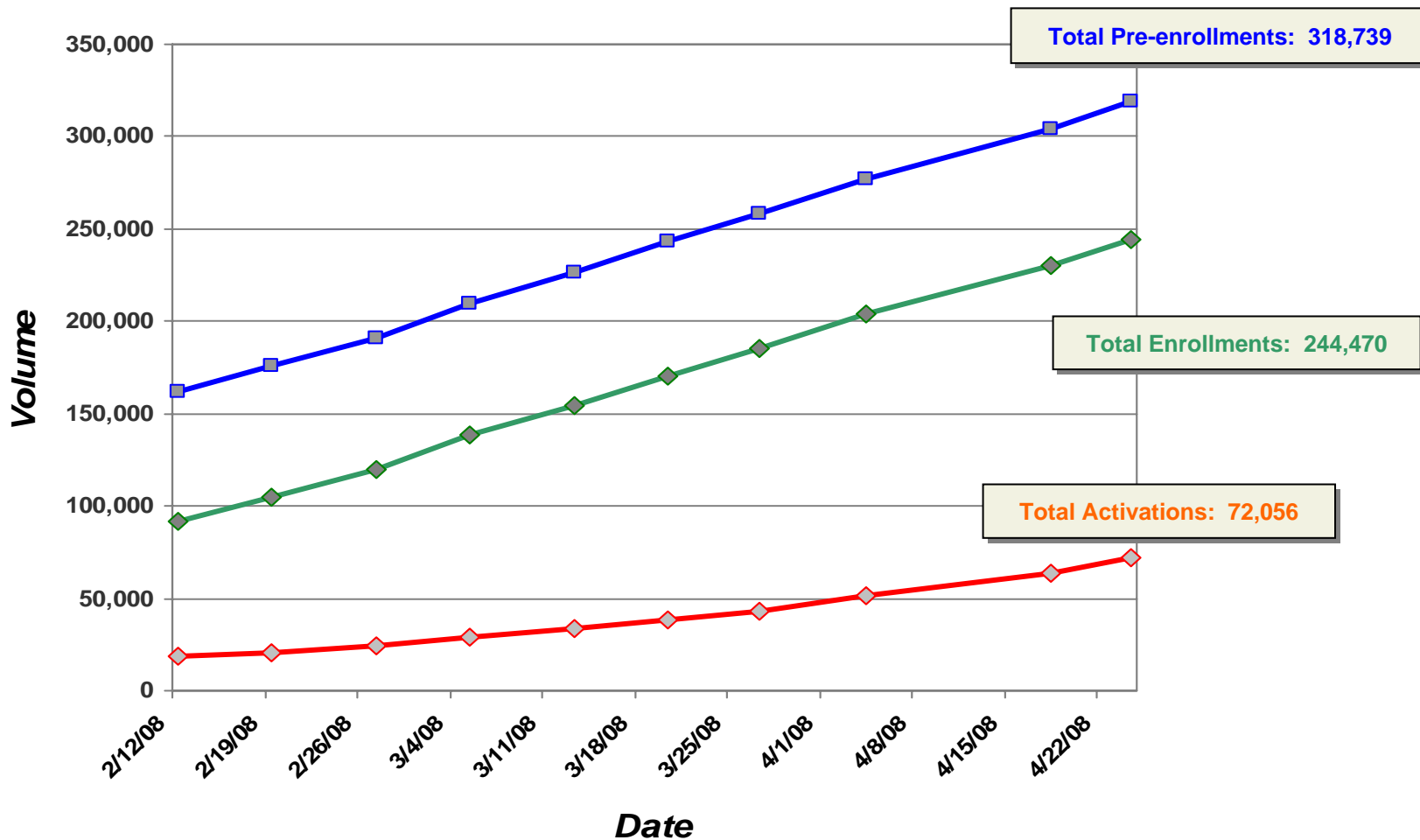
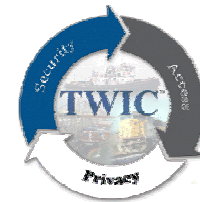
TWIC Program Overview

- **Joint TSA/USCG Program**
- **The Maritime Transportation Security Act and Aviation Transportation Security Act provides the Legislative foundation for the program**
- **TWIC is issued after verifying an applicant's identity and then satisfactorily completing a comprehensive security threat assessment (terrorism, criminal, immigration)**
- **The program is fully fee-funded – user fees must cover all operating costs**
 - **\$132.50 for standard TWIC which is good for five years**
 - **[\$105.25 with comparable STA ... \$60 replacement]**
- **TWIC provides a common, consistent biometric credential which will be required to gain access to “secure areas” at over 3,200 maritime facilities and aboard over 10,000 vessels**
- **Having a TWIC does NOT confer access to maritime facilities, it allows facility and vessel owners / operators to grant unescorted access. They control access to their facilities.**
- **Deployment**
 - **97+ Enrollment Centers open nationwide**
- **Enrollment**
 - **Estimated population: 1.2 Million +**
 - **Over 250,000 workers have enrolled**





TWIC Enrollment Metrics



Two-Phase Program Implementation

Phase I

- Rule now requires workers to obtain TWIC
- Rule will require facility and vessel operators to visually inspect TWIC once initial enrollment is complete in each port as determined and ordered by Coast Guard Sector Commander

Phase II

- Second TWIC rule will require facility and vessel operators to biometrically verify identity and check that the card has not been revoked
- Operators will be responsible for the purchase and operation of readers and access control systems
- To implement, will require contactless card readers that function in the maritime environment



Implementation Factors

- **TWIC is required by a large, diverse population**
- **TWIC covers a wide range of facilities and vessels**
- **That must operate in a wide range of environmental conditions**
- **Many facilities have unique operational and security requirements**
- **TWIC must consider the investment in the existing physical access control infrastructure; as well as the capabilities and limits of information technology**



TWIC Biometric Usage

- TWIC currently uses both fingerprints and facial images
- Fingerprint biometrics are used for two primary purposes:

Verification of identity and conducting the security threat assessment

Fingerprint used by FBI for Criminal History Records Check

One-to-many alias checking

Identity authentication

By matching a worker's biometric to that stored on his TWIC at access control points

- TWIC contains a fingerprint template—which is NOT an IMAGE—on its Integrated Circuit Chip
- Supported by handheld and fixed readers



SAFE Port Act Pilot Test

Pilot Test Requirements:

- Evaluate technical performance of TWIC card / biometric reader function
- Evaluate operational and business process impact of conducting biometric verification of identity in various maritime facility and vessel operating scenarios

Participants

- Ports of NY/NJ; Long Beach; Los Angeles; Brownsville; and, Chicago
- Vessel operations: inland river tug/towing operations Vicksburg, MS; and, small passenger vessel operation in Annapolis, MD
- May add: ocean-going vessel; large passenger ferry; and, Great Lakes facility



Program Successes

- Pre-enrollment Capability: Reduces Overall Enrollment Time
- Extensive use of Metrics and Dashboard: Allows objective identification of trends to take corrective actions
- Use of 1:1 Biometric Match and Quality Algorithm at Enrollment: Minimizes FBI Rejects
- Biometric Uniqueness Check for all Applicants: Ensures Each Holder has Only One TWIC
