PROCEDURES RELATED TO THE CONDUCT OF MILITARY AFFAIRS OF THE MILITARY COMMITTEE, NATO

Reference:

- a. DODD 5100.35, 10 March 1998, "Military Communications-Electronics Board (MCEB)."
- 1. <u>Purpose</u>. This instruction establishes procedures for determining the U.S. military position on military matters before the Military Committee of NATO.
- 2. Cancellation. CJCSI 2010.01F, 1 February 2007, is canceled.
- 3. <u>Applicability</u>. This instruction applies to the Chairman of the Joint Chiefs of Staff, the Joint Staff, the U.S. Representative to the Military Committee (USMILREP), and the U.S. Delegation to the Military Committee (USDELMC).

4. Policy

- a. The USMILREP and staff, known collectively as the USDELMC, will be guided by the following.
- (1) During development of a proposed NATO military position, USDELMC will coordinate with and receive guidance from appropriate directorates, as established in Enclosures A and B. Actions outside the scope of Enclosures A and B should be referred to the Secretary of the Joint Staff (SJS) for Joint Staff tasking.
- (2) In developing NATO military positions, USDELMC will provide recommendations on changes necessary in CJCS-established policy considered necessary to obtain a satisfactory international agreement.

- (3) Once a proposed NATO military position is within the terms of CJCS policy and has been approved by the Military Committee, it will be referred to the appropriate directorate for distribution as required.
- b. The cognizant Joint Staff directorate will consult and coordinate with USDELMC and U.S. members of multinational working groups supporting the Military Committee, providing informal advice, information, support, and CJCS-approved guidance as necessary.
- (1) The Joint Staff and DIA will coordinate with other appropriate U.S. agencies as necessary.
- (2) Enclosure A lists the multinational groups, agencies providing U.S. representation, and the cognizant Joint Staff directorate with primary responsibilities or interest.
 - (3) Enclosure B lists functional area responsibilities.
- 5. Definitions. None.

6. Responsibilities

- a. USMILREP will determine whether the existing policy adequately addresses the issue under consideration by the Military Committee.
- b. The SJS will distribute information to, and task appropriate, Joint Staff directorates as required.
- c. Joint Staff directorates will provide formal and informal coordination with USMILREP and formal responses to SJS tasking.
- d. The USMILREP will assume responsibility for the direction of the United States National Military Representative (USNMR) to Supreme Headquarters Allied Powers Europe (SHAPE) and the United States National Liaison Representative (USNLR) to Supreme Allied Command Transformation. Joint Staff directorates will provide formal and informal coordination with USMILREP, USNMR, and USNLR.
- 7. <u>Summary of Changes</u>. Realigns USNLR under USMILREP and updates Enclosures A and B based upon changes within NATO and functional areas.
- 8. <u>Releasability</u>. This instruction is approved for public release; distribution is unlimited. DOD components (to include the combatant commands), other Federal agencies, and the public may obtain copies of this instruction through the Internet from the CJCS Directives Home Page--http://www.dtic.mil/cjcs_directives.

9. Effective Date. This instruction is effective upon receipt.
