## Bonneville Power Administration's Subscription Power Sales To Customers and Customers' Sales of Firm Resources

On March 19, 1999, Bonneville Power Administration (BPA) distributed background information on two policy proposals related to new power sales contracts. This was done to give interested parties an opportunity to begin reviewing the concepts before these proposals were published in the Federal Register and before the formal comment period opened. BPA is proposing changes to the standards used to determine whether a prospective customer is qualified to purchase Federal power on a preference and priority basis. In addition, BPA is proposing changes to the way decisions are made regarding a customer's sale of its resources out of region and the amount of Federal power a customer is entitled to purchase.

These policy proposals were published in the Federal Register on May 6, 1999, and we now invite your review and comment. The formal comment period is open through June 11, 1999.
