

SCHEDULE OF PUBLIC MEETINGS
Bonneville Power Administration's Regional Dialogue

BPA is engaging the region in a Regional Dialogue public process as part of its effort to provide clarity around key issues facing the agency and the region when the current rate period ends with FY 2006. BPA's immediate goal is to reach agreement on near-term issues that prepare the way for setting rates for the next rate period while assuring that the agency's long-term strategic goals and its long-term responsibilities to the region are aligned.

The agency intends to resolve these power-related issues through this Regional Dialogue public process. The BPA Administrator will make final policy decisions in December of 2004 after all public comments have been reviewed. The Regional Dialogue policy proposal is available now for review and comment. The comment period is open through Wednesday, September 22, 2004. The proposal is posted on the web site listed below:
