Department of Veterans Affairs (VA) Executive Order 13520 – Reducing Improper Payment FY 2010 Third Quarter High-Dollar Overpayments Report

The President signed Executive Order 13520, "Reducing Improper Payments." On March 22, 2010, the Office of Management and Budget (OMB) issued the government-wide guidance on the implementation of the Executive Order. The guidance is under Part III, Appendix C of OMB Circular A-123. This guidance requires agencies with programs susceptible to significant improper payments to submit to the agency's Inspector General and the Council of Inspectors General on Integrity and Efficiency, and make available to the public, a quarterly report on any high-dollar overpayments identified by the agency.

In the 2009 Performance and Accountability Report, VA reported 3 Veterans Benefits Administration (VBA) programs, and 2 Veterans Health Administration (VHA) programs that meet the Improper Payments Information Act of 2002 (IPIA) thresholds for susceptibility to significant improper payments. These programs are Compensation, Pension, Education, Non-VA Care Fee, and Non-VA Care Civilian Health and Medical Program of the Department of Veterans Affairs (CHAMPVA).

In accordance with OMB Circular A-123, Appendix C, Part III, VBA and VHA reviewed the five programs that were susceptible to significant improper payments. The OMB guidelines define a high-dollar improper payment as any payment in excess of 50 percent of the correct amount of the intended payment under the following circumstances:

- 1. Where the total payment to an individual exceeds \$5,000 as a single payment or in cumulative payments for the quarter; or
- 2. Where a payment to an entity exceeds \$25,000 as a single payment or in cumulative payments for the quarter.

The OMB guidelines require that agencies submit, on a quarterly basis, a report to:

- 1. List all high-dollar overpayments identified by the agency during the quarter:
- 2. Describe whether each high-dollar overpayment was made to an entity or individual, and the city/county and state where that entity or individual was located;
- 3. List the program responsible for each high-dollar overpayment error:
- 4. Describe any actions the agency has taken or plans to take to recover high-dollar overpayments; and
- 5. Describe any actions the agency will take to prevent overpayments from occurring in the future.

The report is divided into five parts for each program area and the high-dollar overpayments are identified from the highest to lowest overpayments within each program area. In addition to OMB's guidelines, our report includes two additional categories: the cause of overpayment and the status of overpayment. The status of an overpayment will either be "collection in progress" or "collection in full." Collection in progress is defined as actions taken by VA to recover from future benefit awards or payments, referral to the Treasury Offset Program, or request to return money that was paid after the death of a beneficiary through reclamation procedures. Veterans also have dispute and waiver request rights during the collection processes.

1. Compensation Program

Compensation and Pension Service identified 277 high-dollar compensation overpayments.

One hundred thirty-one compensation overpayments (47 percent) were created due to the death of the beneficiary. Entitlement to benefits ceases effective the first day of the month in which death occurs. These overpayments are caused when a beneficiary dies too late in a month to stop the release of the payment for the month of death, or when VA is not timely notified of the death of a beneficiary.

Fifteen overpayments (5 percent) were caused by retroactive adjustments due to incarceration of the beneficiary. Notification of incarceration is a function of agreements made with States, the Bureau of Prisons, and other law enforcement agencies. Once notified of a beneficiary's incarceration, VA must provide due process notice to the beneficiary before any adjustment may occur.

Seven overpayments (3 percent) were caused when Veterans returned to Active Duty status. The Department of Defense runs a quarterly match of the active duty and VA disability files to identify persons who are receiving active duty pay and VA disability benefits concurrently. Once notified of active duty status, VA must provide due process notice to the beneficiary before any adjustment may occur.

Six overpayments (2 percent) were caused when Veterans were hospitalized at VA expense requiring an adjustment to the rate of payment. Information is regularly exchanged between VA medical centers and regional offices by automated methods when a Veteran is hospitalized at VA expense and is subject to a payment adjustment. Once notified of hospitalization status, the regional office must provide due process notice to the Veteran before any adjustment may occur.

Five overpayments (2 percent) were caused by retroactive adjustments due to the beneficiary's status as a fugitive felon. Law enforcement agencies notify VA when a beneficiary has been identified as a fugitive felon. Once notified, VA must provide due process notice to the beneficiary before any adjustment may occur.

An additional one hundred thirteen (41 percent) potential high-dollar overpayments were identified. These were classified as "Unknown" because there was insufficient electronic information available to determine the overpayment period and/or cause of the overpayment. In order to make such a determination, an additional review of individual claimant files would be required for each overpayment. These overpayments total \$1,380,705.63. Twenty two have been collected in full, totaling \$365,642.16. Collection is in progress for the remainder.

Note:

Some VA overpayments are inherent based on the requirements of 38 CFR § 3.103, Procedural Due Process and Appellate Rights, that does not allow VA to take adverse action regarding the payment of benefits without providing the beneficiary 60 days advance notice, unless the beneficiary requests that VA take the adverse action immediately. This "due process" period often extends an overpayment period by two additional months. The only exception to providing procedural due process is when the VA is notified of a beneficiary's death.

Beneficiaries who are incarcerated or are fugitive felons are subject to a reduction or termination of benefits. Through matching programs, such as the fugitive felon program, the Bureau of Prisons, and other law enforcement agencies, VA receives information regarding incarcerated and fugitive felon beneficiaries after the beneficiary has been incarcerated or deemed a fugitive felon. By law, VA must provide a 60-day "due process" period prior to reducing or terminating benefits. As such, overpayments in these cases most frequently cannot be avoided.

When a beneficiary dies during the latter days of a month, a recurring benefit payment is often made before VA is notified that the death occurred. While VA has a death match program with the Social Security Administration (SSA), the match is received once per month from SSA, and usually after a benefit payment has been released. The number of overpayments following death has been reduced due to VA's VETSNET "real time" processing technology.

While DFAS notifies VA of Veterans who returns to Active Duty, VA must provide a 60-day "due process" period prior to discontinuing benefits, thereby extending the overpayment by two months.

Electronic notice is received when Veterans are hospitalized at VA expense and subject to a reduction in benefits. Again, Veterans must be provided with 60 days "due process" before any reduction in benefits can occur.

2. Pension Program

Compensation and Pension Service identified 21 high-dollar pension overpayments.

Six overpayments (29 percent) were created due to a change in countable income.

Seven overpayments (33 percent) were created due to death of the beneficiary.

One overpayment (5 percent) was due to a hospital expense adjustment.

Seven unknown overpayments (33 percent) were identified, but there was insufficient information available electronically to determine the period covered by the overpayment and/or the propriety or cause of the overpayment.

3. Education Program

Education Service identified 1,473 high-dollar overpayments.

The refinement of criteria for the report to include smaller overpayments resulted in an increase in reportable overpayments for the 3rd Quarter of FY 2010, primarily in overpayments to individuals, which constituted 86 percent of the reported overpayments. Because we remain in the initial implementation period for the Post 9/11 GI Bill, we are subject to a number of factors, each of which materially increases the potential for reportable overpayments.

- 1. Overpayments to entities (i.e., schools) are included in this report as well as those to individuals. There may therefore be two overpayments (individual and entity) resulting from a single cause in some instances. These school overpayments constituted 14 percent of the reported overpayments. These payments to schools for tuition and fees are made in large lump-sum amounts at the beginning of the term. They are based on certifications from the schools which may be made before the beginning of the term, and which may be affected by subsequent enrollment changes.
- 2. Interim manual processing procedures for Post 9/11 GI Bill claims, including authorization of multiple payments per claim, present increased opportunity for operator entry errors.
- 3. The complexity of Post 9/11 GI Bill claims, including separate determinations of basic eligibility and eligibility for housing allowance, can result in increased errors.
- 4. The vast increase of workload during the initial year of implementation generated pressures to work claims as quickly as possible, and also required a doubling of claims processing staff, resulting in a workforce which currently is largely inexperienced. Both these factors contribute to increased errors in other programs in addition to the Post 9/11 GI Bill.

Forty-two percent of the overpayments were caused by provisions of law which require retroactive reduction or termination of benefits after payment has been properly made; this includes requirements to pay some benefits in advance of the student's attendance.

Thirty-two percent of the overpayments were caused by errors or delays in reporting enrollment information by schools.

Twenty-five percent of overpayments were caused by errors or delays in processing by VA.

The few remaining errors had other individual causes.

NOTE:

Many Education overpayments result from provisions of law which can operate to later make payments improper which were proper at the time they were made. These include payments made in advance of an enrollment period, particularly tuition and other benefits under the Post 9/11 GI Bill. If the student does not attend, reduces his course load, or stops attending, some or all of the amounts paid become improper and subject to collection. In addition, provisions applying to Education benefit programs in general forbid the payment of benefits for any course which is not counted toward the beneficiarry's graduation requirements. If a student receives such a grade in a course (whether the course has been completed or not), benefits must be adjusted retroactive to the beginning of the term. To minimize the effects of such statutory provisions, VA provides cautionary information in print publications and electronic media, and also includes this information in letters to students each time they are awarded benefits.

Delays or errors by school officials in reporting information often result in improper payments, particularly if reductions in course load or terminations are involved. The complexity of Post 9/11 GI Bill reporting requirements also can lead to errors on the part of school officials. VA maintains regular contact with school officials to remind them of requirements for timely and accurate reporting, frequently disseminates informational materials, and provides specific training when indicated, such as for the implementation of the Post 9/11 GI Bill.

Delays or errors by VA in the processing of claims also produce improper payments. The complexity of Post 9/11 GI Bill claims, Interim manual processing procedures for those claims, the vast increase of workload during the initial year of implementation and an inexperienced workforce contributed to increased delays and errors, which affected other programs in addition to the Post 9/11 GI Bill. In the short term, VA has hired additional personnel, taken steps to expedite

processing procedures, and provided continual refresher training. In the long term, continued development of automated processing systems is expected to improve both accuracy and speed of processing.

4. Non-VA Care Fee Program

Non-VA Care Fee identified 15 high-dollar overpayments totaling \$398,356.35 for the third quarter of fiscal year (FY) 2010 through the Diagnostic Related Group (DRG) recovery audit for hospital care provided between FY 2003 to 2006. All overpayments have been collected in full or have been referred to the United States Department of the Treasury for offset. Due to the success of the recovery audit program, the VHA Chief Business Office (CBO) is in the process of awarding a new recovery audit contract to audit FY 2007 to 2011 inpatient claims. The new contract will begin reviewing FY 2009 claims. Additionally, CBO is expanding the recovery audit to include high dollar outpatient services. The contract for these services is currently in the solicitation phase.

Fee Basis Claims System: CBO has initiated installation of a commercial off-the-shelf product into the program, allowing integrated claims scrubbing, automated identification of duplicate payments, and system-wide use of electronic claims processing. This tool, installed at approximately 50 percent of all sites, will assist with addressing errors tied to manual data entry.
- 3. The CBO Fee Program Office developed an audit tool to provide local managers the capability to analyze their own results in regards to overpayments. This tool was released to the local facilities in the second quarter of FY 2010 and was used during the annual IPIA audit.
- 4. Training CBO has presented multiple trainings this past year on internal controls. In addition, monthly training offerings are now available via Live Meeting allowing broader staff participation in these key events.
- 5. Site Assessment Visits CBO created a Field Assistance Unit to provide assistance in improving local operations by assessing current site status and assisting with the development of increased management control. Approximately 52 sites have been assessed with additional tools developed based on those site visits.

5. Non-VA Care CHAMPVA Program

Non-VA Care CHAMPVA did not identify any high-dollar overpayments for the third quarter of FY 2010. The majority of CHAMPVA payments are to entities and approximately 99 percent of payments are under \$1,000. Only .02 percent of claims exceed \$25,000. To identify high-dollar overpayments, the Health Administration Center (HAC) reviewed (1) a quarterly possible duplicate payment audit, (2) a quarterly claims audit, (3) an ongoing weekly high-dollar audit for all claims over \$100,000, and (4) an annual high-dollar audit of claims between \$10,000 to \$99,000. The HAC conducts a 100 percent multi-division in-depth prepayment review of all claims over \$100,000 and the Claims Processing Division conducts a prepayment review of all claims over \$10,000 to reduce the likelihood of a high-dollar improper payment being made.
