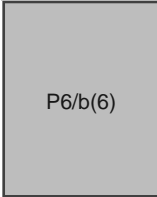

The Century Council is a non-profit organization dedicated to reducing alcohol abuse across the United States. Primary areas of focus include drunken driving and underage drinking problems. The Century Council is funded by a group of concerned brewers, vintners, distillers, and licensed beverage industry wholesalers.

The Century Council has been active in support of the passage of Administrative License Revocation (ALR) laws in the states without such statutes, and has helped pass the law in Nebraska, New Hampshire and Ohio in the last year.
