1. The Community of Caring reduces teen pregnancy
 - o Not a demonstration program. Our results are verified
 - o Has been demonstrated in a variety of environments, i.e. inner city, suburban, and rural
 - o Program delays the onset of sexual intercourse
 - o INSERT ARCHER STATISTICS
 - o Program promotes a basis for sound decision-making which leads to responsible behaviors

2. Our program is absolutely compatible with H.H.S. and Surgeon General's objectives
 - o Reduces teen pregnancy
 - o Provides a basis for sound decision-making in order to avoid destructive behavior
 - o Very appropriate for addressing the issue of violence towards women because program accesses both boys and girls
 - o Program designed for all populations not just students at risk
 - o Substantial program, not short-term

Dear Ms. Rasco:

The Trustees of the Joseph P. Kennedy, Jr. Foundation are happy that they are able to fund Stanley S. Herr for one year as a Kennedy Public Policy Fellow. Professor Herr has agreed to serve as a volunteer at The White House, reporting directly to you. The Kennedy Foundation will finance this fellowship through the University of Maryland, School of Law, for this one year period while Professor Herr is on public service leave from the University.

The Kennedy Foundation and our Public Policy Fellowship program have a long and distinguished history working with persons with mental retardation and their families. Because of the Foundation's history and policies, I need to assure our Trustees that the Foundation's investment in this area will have direct benefit to persons with mental retardation and their families. To accomplish that responsibility, may I, with your approval, explain to the Trustees that Professor Herr will work as follows:

- 1) Professor Herr will have access to consult with you regularly about issues impacting persons with mental retardation and their families;
- 2) So that he may benefit from this experience and be of most help to persons with mental retardation, Professor Herr will be involved in discussions and be given the chance to review all matters concerning mental retardation, matters such as legislation, statements by the President, Executive Orders


and speeches in draft or discussion phases, prior to their going out of the White House for public consumption. Professor Herr is a recognized expert in the field of mental retardation policy and law, and can be helpful to you in these areas;

- 3) Professor Herr will be designated as an assistant to you, and we trust that he will speak on your behalf, when authorized;
- 4) I understand that Professor Herr will be able to work on the health bill before it is introduced. We are concerned about the provisions in that bill dealing with dental care for adults with mental retardation, additional reimbursement for practitioners who normally have to devote extra time to persons with mental retardation, mental health care for persons with mental retardation and prescription medication for persons with mental retardation.

I look forward to meeting with you in September, and discussing the wonderful opportunities available under President Clinton to improve the lives of persons with mental retardation and their families in this country. In the meanwhile, once we have received your response to this letter, we will confirm our arrangements with the University of Maryland. Professor Herr will confirm his starting date with you personally and directly.

I understand that Professor Herr can begin work late this month. I am delighted that someone of Professor Herr's stature will be given the time to work on these issues with the Administration. We are pleased to be able to aid this distinguished scholar as he works on this important area of National policy. I look forward to regularly meeting with both of you on issues that are important to persons with mental retardation and their families.
