Director of the Office of Management and Budget

Discusses the financing of Health Care Reform and its impact on the federal deficit.

Carol Rasco

Domestic Policy Advisor to the President

Discusses likely policy changes in the President's proposal; compare and contrast with other policy proposals and principles.

David Wilhelm

DNC Chairman

Discusses the DNC's role in promoting Health Care Reform; interaction with other reform groups.

Chairman Wilhelm concludes session, thanking panelists and inviting guests to board buses to the White House.

TALKING POINTS/ABOUT THE AUDIENCE:

* This is the first formal gathering of the Trustees as a group since the election. For that reason, it is not out of place to acknowledge that President Clinton and this Administration would not be here were it not for the support of the Trustees in the room.

* FYI--To become a Trustee within the group present today, they had to raise or write checks for at least \$100,000 during the 1992 campaign. These are the 483 biggest contributors to the Democratic Party (the audience will represent about 300 of them).

* Because of the support of the Trustees in 1992, look what Democrats did in November of last year. With their continued support this year, look at what has been done in the past nine months (name Administration accomplishments). Just think of what we can do in the 30 months we have left.

* Without a doubt, the financial support of the people in this room made victory a reality in 1992. But we realize that you are all leaders in the community, in your own business and in every walk of life. We need you as leaders in the community to support this President and this Party at every turn; making the case for the causes that brought us all together last year. (There are two tables of talking points outside the ballroom: one on Health Care Reform and one with various issue talking points for the Trustees to take with them).

* Most of the Trustees are long-time Democratic supporters. They have been friends of the Democratic Party through good and bad times. Their unwavering support will make the next four years not just good times, but great times.
