Classification Officer's Responsibilities

You are hereby appointed as the Office of Science (SC) Program Classification Officer for SC activities at Oak Ridge, Tennessee, effective immediately at the following facilities:

Oak Ridge Office
Oak Ridge Institute for Science and Education
Oak Ridge National Laboratory Site Office
Oak Ridge National Laboratory
Office of Scientific and Technical Information

You have been the Classification Officer (CO) of the Oak Ridge Office since March 31, 2009. This encompassed not only the SC activities, but also activities of the Offices of Environmental Management (EM) and Nuclear Energy (NE). With the August 15, 2011, reorganization of the Oak Ridge Office and the creation of three site offices, your CO appointment and classification/declassification authorities need to be realigned to reflect the new organization. Effective immediately, you will be the Federal CO for the following facilities:

EM Oak Ridge Site Office
Portsmouth/Paducah Project Office (EM--under a support agreement)
Nuclear Fuel Supply Oak Ridge Site Office (NE)
