

SUBJECT: ETA Performance & Reporting Summits 2007

**Purpose.** To announce three national education and training sessions on performance reporting and management. These training sessions are intended to introduce and clarify the reporting changes contained in the Workforce Investment Streamlined Performance Reporting (WISPR) System, further enhance states' ability to report against the common measures and provide a venue for discussing policy questions. Attendees will have the ability to raise issues with federal staff and learn what other states and local areas are doing to support integration by targeting multiple programs. The session will also deal with ways to reduce data validation issues in the workforce system by providing targeted training on common issues, and provide information, clarification, materials and tools to participants to support state and local training efforts.

**Background.** In the winter of 2006, the Employment and Training Administration (ETA), in collaboration with the Veterans' Employment and Training Service (VETS), sponsored three highly successful national sessions on program reporting and performance management with a focus on the common measures and ETA TEGL 17-05. The sessions were based on the theme *Common Measures: Common Message*. This training was followed by six webinars, each of which focused on areas related to Common Measure implementation. The theme for this round of sessions will be: **ETA Performance & Reporting Summits: Innovation Driving Integration.**

**Target Audience.** Individuals that work in the publicly funded workforce systems at the state and local level are the targeted audience for this training. Recognizing that states are the natural providers of technical assistance to local grantees, states may want to consider sending training teams to these sessions. Each training team should have representation from each of the covered program areas. We ***strongly recommend*** that states encourage local attendance at these training sessions. We urge states to consider attendance as a strategic investment in the State's workforce system. Program administrators and staff responsible for performance management (pertaining to ES, VETS, WIA, NEG and TAA programs) should attend these sessions.

**Locations.** There will be three education/training sessions on program reporting and performance management for programs under WIA (Adult, Youth and Dislocated Worker), Wagner-Peyser, VETS and the Trade Act. The sessions will be held in the following locations:
