1.0 SCOPE OF WORK/DESCRIPTION OF GOODS (COMMODITY CODE 208-68):

In accordance with Education Code 51.9335, the University of North Texas System, subsequently referred to as UNTS, is accepting proposals and intends to enter into an agreement with a vendor that specializes in Construction Management Software System for Capital Projects in accordance with the terms and conditions and requirements set forth in this Request for Proposal. The resulting pricing, terms and conditions shall be extended to the University of North Texas System (UNTS), the University of North Texas (UNT), the University of North Texas Health Science Center (UNTHSC), University of North Texas at Dallas (UNTD) and any other institutions of higher education interested in utilizing the agreement, as allowed by the Texas Education Code.

1.1 - SPECIFICATIONS

This Request for Proposal is an invitation to a select group of companies to submit proposals for a Construction Management Software System for Capital Projects for the University of North Texas System Facilities Planning and Construction (UNTS). The intent is to obtain information leading to the selection of a Construction Management Software System for Capital Projects that will best meet the project and management information needs of UNTS.

Respondents who are selected for further consideration will be requested to make on site presentations and demonstrate their system.

UNTS requires that all proposed software currently be installed and operating at one site. If developmental software or enhanced versions of existing software is included in the overall package being proposed, the nature, status, and timing of development and delivery activities should be clearly stated. A Cloud based system is preferred but will consider a hosted system.

Please submit two (2) copies of your response in the form of one (1) paper copy loose and one (1) virus free CD ROM or flash drive to the address above. Both formats must contain the exact same information. Missing information from either format may result in the Owner's rejection of the response. Email or faxed responses will not be accepted. 1.1.a - FACILITY PROFILE

With a staff of 20 employees including architects, interior designers and other construction and administrative professionals, the University of North Texas System Facilities Planning and Construction office provides professional planning, design and construction management for the University campuses for all major renovation and construction projects located on multiple campuses in the Dallas/Fort Worth area. The responsibilities range from initial programming, design, construction and commissioning. Working closely with the administration, faculty staff and students, the System Facilities Planning and Construction Office implements the highest standards in design, particularly focusing on high-performance, efficient and sustainable facilities. The current 5 year Capital Improvement Plan is approximately \$400 million. Currently UNTS does not have a Construction Management Software System for Capital Projects.

Currently UNT System Facilities manually documents and tracks multiple capital projects under construction on all campuses using various spreadsheets and databases. The process is not interconnected and requires duplication of work, leads to redundancy and errors and requires extensive amount of resources to maintain. The department is seeking proposals for a software system and implementation services.

Minimum requirements include, but are not limited to a web-based system, ability to support multiple capital projects, and utilize different construction project delivery methods. The system must integrate the complete project life cycle from planning, feasibility, programming, design, construction and final close out with the ability to access archived documents for ongoing operations and maintenance and daily current reports on encumbered and expensed funds. The system must be capable of tracking Capital Project Planning including capital fund management, detailed project cost, schedule, and document management with the ability to provide dashboards and generate customizable reports as needed. It is also desired that the system be capable of tracking detailed information for buildings, space, utilities or the ability to integrate with other tracking software.

3.0 EVALUATION:

As provided by statute, awards will be based on the best proposal most advantageous to UNTS. Determination will be made by consideration of prices proposed, delivery date, quality, general reputation, and performance of the respondents, service as related to past performance, suitability of items for the intended use and conformity to specifications, terms and conditions of this Request for Proposal. UNTS reserves the rights to reject all proposals that UNTS determines in its sole judgment are not in the best interest of the institution.

4.0 SELECTION PROCESS:

Selection of the Successful Proposal submitted in response to this RFP by the Submittal Deadline will be made using the competitive process described below.

After the opening of the proposals and upon completion of the initial review and evaluation of the proposals submitted, selected respondents may be invited to participate in oral presentations. The selection of the Successful Proposal may be made by UNTS on the basis of the proposals initially submitted, without discussion, clarification or modification. In the alternative, selection of the Successful Proposal may be made by UNTS on the basis of negotiation with any of the respondents. At UNTS's sole option and discretion, it may discuss and negotiate all elements of the proposals submitted by selected respondents within a specified competitive range. For purposes of negotiation, a competitive range of acceptable or potentially acceptable proposals may be established comprising the highest rated proposals. UNTS will provide each respondent within the competitive range with an equal opportunity for discussion and revision of its proposal. UNTS will not disclose any information derived from the proposals submitted by competing respondents in conducting such discussions. Further action on proposals not included within the competitive range will be deferred pending the selection of the Successful Proposal, however, UNTS reserves the right to include additional proposals in the competitive range if deemed to be in its best interest.

After the submission of proposals but before final selection of the Successful Proposal is made, UNTS may permit a respondent to revise its proposal in order to obtain the respondent's best final proposal. UNTS is not bound to accept the lowest priced proposal if that proposal is not in its best interest, as determined by UNTS.

UNTS reserves the right to: (a) enter into agreements or other contractual arrangements for all or any portion of the Scope of Work set forth in this Proposal with one or more respondents; (b) reject any and all proposals and re-solicit proposals; or (c) reject any and all proposal and temporarily or permanently abandon this procurement, if deemed to be in the best interest of UNTS.

4.1 Evaluation of Criteria: The successful proposal will be the proposal that is submitted in response to this Proposal by the Submittal Deadline and is the most advantageous to UNTS in UNTS's sole discretion. Proposals will be evaluated by an evaluation committee that will include employees of UNTS and other persons invited by UNTS to participate. The evaluation of proposals and the selection of the Successful Proposal will be based on the information provided to UNTS by the respondent in response to the Specifications section of this Proposal. Consideration may also be given to any additional information and comments if such information or comments increase the benefits to UNTS. The successful respondent will be required to enter into a contract acceptable to UNTS.

The evaluation committee will determine if Best and Final Offers are necessary. Award of a contract may be made without Best and Final Offers. UNTS may, at its discretion, elect to have Respondents provide oral presentations and respond to inquiries from the evaluation committee related to their Proposals. A request for a Best and Final Offer is at the sole discretion of UNTS and will be extended in writing

In evaluating Proposals to determine the best value for the State, UNTS may consider information related to past contract performance of a Respondent including, but not limited to, Texas Comptroller of Public Account's Vendor Performance Tracking System.
