## **Graduate Certificate in Campus Safety and Security Administration**

CJUS 5800 Comparative Issues in Campus Safety and Security

Study abroad option.

March 8-15, 2015 (Eight days)

This 3.s.h. graduate class comprises of an eight day course taken in England and France.

The theme of this class is to present course participants to contemporary safety and security issues being faced by institutions of higher education and law enforcement agencies in England and France. Class time is spent in a variety of locations; at the University of West London, Oxford University, with the Police Nationale of Paris and on occasions walking with Dr. Johnstone as he discusses and explains important locations and venues pertinent to safety and security topics. This course is designed to ensure that participants will have the opportunity to exchange ideas and practices with senior managers and executives responsible for higher education safety and security in the UK and France. Throughout the time abroad course members will have access to all the transportation systems of both London and Paris in order that, when not in class, you can take advantage of these wonderful cities to explore. It is expected that course participants will be employed as senior manager/executive in a college or university. Dr. Peter Johnstone is a native of London, a former police officer and a former university chief academic officer. He conducted doctoral research in Paris. Peter holds a master's degree in International Law (LL.M.) a master's degree in Colonial American History (M. Res) and a Ph.D. in Comparative Law. He is co-editor of Managing Campus Safety and Security in Higher Education and he teaches the CJUS 5370 Law and Policy in Campus Public Safety module for the Graduate Certificate in Campus Safety and Security Administration.

Program itinerary.

Day one. Direct flight with British Airways from Dallas to London.

Day two. Having arrived in London and checked into our hotel we will spend some time familiarizing ourselves with the London transport system, the 'double decker's and the Tube. This evening we will spend some time socializing together as a group in order that participants can begin to share experiences and establish professional links and relationships that will be of value to you throughout your careers. Whilst in Europe a number of meals will be taken together as a group. On those occasions when we are not together participants are free to explore local restaurants.

Day three. Lunch today will be taken as guests of Dr. Johnstone at Middle Temple, one of the four Inns of Court of England & Wales. Middle Temple sits in the heart of Legal London. The magnificent Tudor dining hall serves as a restaurant for judges and lawyers from the nearby Royal Courts of Justice. It is a unique experience. After lunch we travel to the University of West London where District Court Judge Tan Ikram will run a workshop on sentencing practices that have involved university students who have been convicted of a criminal offence. This will be followed by a discussion session and dinner with faculty and staff of the Ealing Law School. We will be joined by a number of local lawyers, senior police officers and community members.

Day four. Today we will travel to Oxford where we spend the day with the Director of Security at Oxford University, Paul Sullivan. Paul and his colleagues will present issues related to campus safety and security that involve high profile students and their families. There will be an opportunity to visit some of the famous colleges with the provost (the equivalent of the head of police for the university). This will be followed by dinner in Oxford.

Day five. Depart London for Paris via the high speed train, Eurostar. After checking into our hotel Dr. Johnstone will familiarize course participants with the transportation system and provide a walking tour of criminal Paris. Dinner will be taken in the Latin Quarter, opposite Notre Dame.

Day six. Today we are guests of the Police Nationale of Paris. Chief Julien Miniconi, who has responsibility for the 10<sup>th</sup> arrondissement is also head of public order in Paris, a role that includes safety and security provision on a number of university campuses. We will also receive a presentation on terrorism and university campuses from Chief Francois-Xavier Masson. Chief Masson is with EUROPOL. Optional dinner with Julien Miniconi and Francois Masson.

Day seven. This is a free day to explore and enjoy the wonderful sights of Paris. There will be a group dinner tonight at the famous 'Le Procope' restaurant.

Day eight. Depart Paris for return flight to Dallas.

There is no foreign language requirement and all classes and presentations will be conducted in English.

At the conclusion of the study abroad element students will be required to complete a research paper of a comparative nature under the direction of Dr. Johnstone. This will be completed throughout the remainder of the spring semester.

Cost. \$3939. This price includes: Return flights with British Airways, transfers to London from Heathrow and Paris hotel to airport, four star hotels in central London and Paris (twin rooms, with private bath), full breakfast each day, 24 hour transportation on London and Paris train, 'Tube', metro and buses, return transportation to Oxford from London, Eurostar from London to Paris. Lunch at Middle Temple, Dinner in Oxford, Dinner at the University of West London, Final dinner at Le Procope, Paris.

Please note this does not include the cost of 3.s.h. of graduate tuition which is payable separately.

Course participants may bring spouses/partners. Attendance at programmed events is not required (but may be taken) by non-student Friends of UNT. Travel cost. \$3939. No tuition.

Please note that for those attending as Friends of UNT there will be the option to participate in a number of cultural events led by Christine Pincemin-Johnstone. Christine is a native of Paris and an artist. She has a vast experience in leading study abroad classes and has lived in both cities.

This Study Abroad course is strictly limited to fifteen student (for credit) participants each year. This maximum does not include non-student participants who are attending as Friends of UNT.
