Texas among 5 New SARA States in SREB

SARA helps states make distance education more accessible across state lines

On October 28, Alabama, Georgia, Maryland, Mississippi and Texas were approved by the Southern Regional Education Board (SREB) to join the State Authorization Reciprocity Agreement (SARA). These states bring the number of participating states to 34, with over half the SREB states participating in SARA.

SARA is a nationwide initiative of states that will make distance education courses more accessible to students across state lines and make it easier for states to regulate and institutions to participate in interstate distance education. The effort is funded by a \$3 million grant from Lumina Foundation, \$200,000 from the Bill & Melinda Gates Foundation, and fees paid by institutions.

SARA makes it easier for states to regulate interstate distance education, and it eliminates approval costs for colleges and universities that are often passed to students. Institutions in the five SREB states may now join the clearinghouse through the reciprocity agreements.

"SARA increases access to education especially for adult students who juggle other responsibilities when they return to complete degrees, says SREB President Dave Spence. "Education remains critical to state goals to increase college completion rates and build a better-educated workforce."

SARA agreements are overseen by the National Council for State Authorization Reciprocity Agreements (NC-SARA) and are being implemented by the four regional higher education interstate compacts: the Midwestern Higher Education Compact (MHEC), the New England Board of Higher Education (NEBHE), the Southern Regional Education Board (SREB) and the Western Interstate Commission for Higher Education (WICHE). Texas is a member of SREB.

The Texas Higher Education Coordinating Board (THECB) will serve as our state "portal agency" for SARA.


SARA aims to simplify how college and universities become authorized to offer distance education to students in other states. In the past, individual institutions had to apply to operate in every state from which they intended to enroll students -- a very time-consuming and expensive process that involved navigating and keeping up with each state's changing regulations.

Didyou know?

Basically, in the past, it was a process similar to that system to having to get 50 different driver's licenses to be able to drive in every state. SARA, similar to how driver's licenses actually work, has to do with reciprocity. Once a state joins SARA, institutions there can apply for blanket approval to offer distance education to students in the other member states.

We're really excited now that UNT Dallas has the opportunity to become a member of SARA.
