Randall L. Exley The Auditor General Headquarters, Department of the Army Washington, DC



Mr. Exley was appointed to the Senior Executive Service in July 2002, and has 40 years of Federal Service in the Departments of the Army (18 years) and Navy (22 years). He assumed the duties of The Auditor General, U.S. Army on April 25, 2010. As the Army's Auditor General, Mr. Exley is responsible for managing the worldwide operations of the U.S Army Audit Agency, a 600 person organization with an annual budget of about \$70 million. The Agency's mission is to provide objective and independent internal auditing services to help the Department of the Army's leaders make informed decisions, solve problems, use resources effectively and efficiently, and satisfy statutory and fiduciary responsibilities. Mr. Exley is also responsible for internal audit policy, training, and follow-up, and for liaison with external audit organizations.

Previously, as Deputy Auditor General of the Navy working for the Naval Audit Service (NAVAUDSVC), Mr. Exley was responsible for co-leading the organization with its 400 personnel and \$42 million annual budget. NAVAUDSVC helps the SECNAV, and other political, military, and civilian executives, solve problems through assessing and mitigating risk, and providing internal auditing services. NAVAUDSVC audits help prevent and detect fraud, waste, and abuse, and help ensure that Departmental programs, activities, systems, functions, and funds are effectively and efficiently managed in compliance with laws and regulations.

Mr. Exley served as Assistant Auditor General for Research, Development, Acquisition, and Logistics Audits from July 2002 to September 2004. In that capacity, he led a Directorate of 80 audit professionals in the performance of internal audits that focused on Navy and Marine Corps contract award and administration, and major program acquisitions funded by the Research, Development, Test, and Evaluation Appropriation; the Weapons, Aircraft, Ammunition, National Guard and Reserve Component, and Other Procurement Appropriations; and the Ship Construction, Navy Appropriation. Prior to joining the SES, Mr. Exley served as a GS-15 from 1988 to 2002 in a variety of audit management and field office management roles in the Department of the Navy.

Prior to employment with the Department of the Navy, Mr. Exley served 17 years in the Army Audit Agency, including 2 years of enlisted Active Duty service and 15 years as a civil servant. He served in a variety of positions, in grades from GS-5 through GS-14. During his career with the Army Audit Agency, Mr. Exley served in Atlanta, GA; Frankfurt and Kaiserslautern, Germany; Hampton, VA; and Washington, D.C.
