
MEMORANDUM FOR DCMA COMPONENT HEADS

NOTES:

1. Precedence is determined by position.
2. Officials designated as “Acting” or otherwise representing above-listed positions will be afforded the protocol level for the position in which designated as “Acting.”
3. Unless acting for their principal, deputies may be arranged differently from other principal officers for seating and other matters (e.g. deputies may be seated behind their principal at meetings, rather than at the table).
4. Any additional personnel not otherwise specified in the DCMA Order of Precedence will be ordered after Group 5 by rank, date of appointment, and date of rank.
5. This memorandum supersedes all previous DCMA Orders of Precedence.
