This Position is an API 8.

- Responsible for the development of the ANG's MAF portion of the Program Objective Memorandum (POM) and President's Budget (PB). Position requires military training and expertise in developing MAF, special operation forces (SOF) structure, and funding options supporting the full spectrum of operational requirements for the United States Air Force (USAF) and ANG. Requires current rated officer to serve as interface between ANG and Headquarters Air Force (HAF) programming community, MAF, and SOF community for validating operational requirements for like-airframe modifications to support programmed initiatives.
- Operational MAF or SOF experience is highly desired. Other highly desired qualifications include: extensive background in, knowledge of, and experience within the MAF/SOF community. Familiarity and/or experience with the Planning, Programming, Budgeting, and Execution (PPBE) system, as Program Element (PE) or acquisition program manager, is highly desired. Should have a working knowledge of the functions and organization structure of the NGB, USAF, major command (MAJCOMs), Numbered Air Forces (NAFs), the Adjutants General (TAGs), National Guard- Joint staff (NG-JS), and ANG.
- As a MAF/SOF programmer, member will work directly with MAF Program Element Monitors (PEM) and MAF/SOF Functional Area Monitors (FAMs) to guide and direct ANG's PPBE efforts as they relate to MAF operations. Coordinates with HQ USAF, MAJCOM, JFHQ-states and ANG field units to determine program requirements. Member will coordinate with and represent ANG MAF resource equities with numerous commands, including Air Mobility Command (AMC).
- Incumbent will develop, present, and coordinate MAF/SOF PPBE issues for the ANG, and is responsible for ANG MAF & SOF programming guidance, analysis, and resource recommendations to the Director, ANG, through the MAF Panel. Responsible to track MAF/SOF related issues throughout the ANG Corporate Process and AF Corporate Structure and incorporates recommendations. Member will monitor execution of authorized funding.

- Member of the ANG MAF panel. Works closely with other members of the Plans and Programs directorate and interacts daily with the integration branch to define, integrate, and support ANG requirements with other ANG directorates and commands. Develops ANG POM for assigned program element (PE) inputs and to support/defend ANG interests at unit, MAJCOM, and HQ USAF levels.
- Should have the ability to analyze logically and objectively, apply sound judgment in assessing possible solutions, and adjust to changing priorities; and be able to implement these traits in daily operations. Strong leadership, management, and effective communication skills are in high demand for this position.

All field members to include AGR, Technicians & Drill Status Guardsmen must obtain State TAG approval with application submittal. Members currently assigned to the Statutory Tour program must obtain current Director's approval.

Statutory Tour service time does not count toward Reduced Eligibility Age for Reserve Retirement Pay.

Statutory Tour members may be eligible for the Post 9/11 GI Bill if they serve on active duty Title 10 and/or Title 32 502(f) AGR for 90 days or more, after 11 September 2001. Their eligibility percentage starts at 40% for 90 days to 5 months. It increases 10% every 6 months, maxing out at 100%.
