- Responsible for advising the Component Numbered Air Force/Air Forces Forward (C-NAF/AFFOR) A6 on a wide array of cyberspace systems operations policy implementation & adherence to include proper operation of Command, Control, Communications, Computers, Intelligence Surveillance, and Reconnaissance (C4ISR) systems Program Management Office mission systems as well as formal training, personnel qualifications, & daily resource management programs. ISR
- Plans, organizes and directs on-site technical assessment visits with subordinate Eastern/Western Air Defense Sectors as well as functional Air Defense Sector counterparts located in Alaska & Hawaii (USPACOM AOR) and Canada. Ensures compliance of established policies & uses experience/skills to identify discrepancies and determine corrective actions (& subsequent follow-up) for senior sector staff and CONR-1AF senior leadership.
- Focal point for developing, coordinating, implementing, reviewing & initiating updates of cyberspace operations/communications-related policies impacting continental air defense and counterdrug communications and computer requirements for the Continental NORAD Region (CONR), subordinate Air Defense Sectors, and the 601st Air Operations Center (601 AOC); 156 FAA-operated radar sites and 146 Ground/Air/Ground (GAG) facilities; 23 alert fighter locations; and U.S. Customs Service in support of air defense and counter-drug missions.
- Partners with both technical experts and functional representatives as required to ensure effective policy implementation & adherence of policies governing AFNORTH's command and control (C2) operations across the USNORTHCOM Area of Responsibility. These wide ranging policies may include tasks associated with engineering, program control, configuration management, test, manufacturing and quality assurance, and integrated logistics support.
- Coordinates implementation, updates, and formal assessment of adherence to all applicable/governing cyberspace-related policies & guidance originating from Department of Defense (DOD), Headquarters Air Force (HAF), Air Combat Command (ACC), Air Force Space Command (AFSPC)/24th Air Force (AFCYBER) as well as joint/direct reporting agencies (i.e. Unified Commands, Defense Information Systems Agency [DISA], and the Joint Staff) pertaining to operations on the Global Information Grid for C4ISR systems.

- Provides overall program/project management in the form of inputs, technical & formatting guidance for the planning, coordinating, managing, sharing, and controlling of CONR-AFNORTH/A6's cyber-related policies & procedures. Interfaces and/or assists with on-line collaboration tools. Partners with other CONR-AFNORTH Directorate Staff to provide necessary support to the CONR-AFNORTH/A6 Directorate and subordinate sectors on cyberspace system operations documentation/references that will be placed on the AF Portal, CoP, and SharePoint sites.
- Will support CONR-AFNORTH Contingency Action Team (CAT) and contingency cell operations for real-world events and exercises as required.
- Performs other duties as assigned.

3. Application Reminders

4. About Statutory Tours

This is a fully funded Permanent Change of Station (PCS). Visit DFAS website for most current Basic Allowance Housing (BAH) & Basic Allowance Substance (BAS) rates for the duty location listed on this announcement.

All Members assigned to the Statutory Tour program will remain affiliated their state/territory while serving on Statutory Tour.

All field members to include AGR, Technicians & Drill Status Guardsmen must obtain State TAG approval with application submittal. Members currently assigned to the Statutory Tour program must obtain current director's approval.

Statutory Tour members may be eligible for the Post 9/11 GI Bill if they serve on active duty Title 10 and/or Title 32 502(f) AGR for 90 days or more, after 11 September 2001. Their eligibility percentage starts at 40% for 90 days to 5 months. It increases 10% every 6 months, maxing out at 100%.

Statutory Tour service time does not count toward reduced eligibility age for reserve retirement pay.
