1. <u>Requirements</u>

All applicants are strongly encouraged to thoroughly review all application procedures and FAQs prior to contacting NGB/HR and especially prior to submitting your application

Must hold rank/grade, AFSC requirement, and be current/passing within fitness standards as established by AFI 36-2905, by and through announcement closeout date. All information must be accurately indicated on the vMPF RIP at the time of application.

Must have or be able to obtain a TS/SCI (Top Secret/Sensitive Compartmented Information) security clearance.

If currently assigned to a Special Duty Identifier (SDI), you must provide a conditional release memorandum from the career field manager/functional area manager.

2. Position Description

Performs the duties during exercises and real-world contingencies and may work an extended, surge work schedule. Conducts sustained air and space operations within its assigned area of operations (AO) to deter, prevent, and if necessary defeat hostile air attacks within NORTHCOM, its citizens, and designated critical infrastructure. When directed by CDRUSNORTHCOM, provide full spectrum USAF air and space capabilities and conduct Defense Support of Civil Authorities (DSCA) to assist civil authorities during emergencies, natural or man-made disasters, and other approved activities of First Air Force and the NORAD Region.

Coordinates plans with coalition forces, DoD agencies, USNORTHCOM, USAF and service force providers to ensure coherent planning efforts to provide C4 capabilities during normal operations and contingency operations.

Provides mission critical Radio Frequency (RF) voice and data services throughout the AF Forces (AFFOR) Area of Responsibility (AOR). Supports USNORTHCOM, 1AF/CONR-AFNORTH and Joint Task Forces (JTF) commanders with command and control communications, computer support, and information resources management.

Plans, engineers, installs, and maintains capability to collect, process, disseminate, and use information. Directly supports 1AF/CONR-AFNORTH's RF architecture and C4 operations sustaining the surveillance, fighter interceptor, counter-drug and DSCA activities of First Air Force and the NORAD Region. Responsible for advising the AFNORTH A6 on a wide array of cyberspace systems operations policy implementation and adherence to include proper operation of Air Force communications systems (satellite communications, radio, radar, computer, network, telephone, and circuits). Plans and organizes communications and information life cycle management activities.

Manages cost, schedules, performance, and support of expeditionary programs supporting CONR field units. Reviews, analyzes, and provides solutions complex technical problems involving systems compatibility, circuit management, satellite linkages, and networking. Provides input to the planning, programming, and budgeting system for the sustainment of AFNORTH related communications circuits. Acts as functional consultant for the integration of RF systems and technical architectures. Provides and interprets federal, DoD, Air Force, and MAJCOM guidance on procedures, policies, and standards. Provides staff assistance to 1 AF assigned units concerning RF and C4I related issues.

Processes and reviews RF and C4 systems requirement documentation, telecommunication service requests, status of acquisition messages, and telecommunication service orders. Performs strategic and budget planning for networks. Reviews and implements C4 systems requirements.

Performs strategic and budget planning for systems hardware and software. Coordinates and implements system service level agreements and memorandum of understanding with user agencies. Manages, supervises, and performs planning and implementation activities. Manages implementation and project installation and ensures architecture, configuration, and integration conformity.

Develops, plans, and integrates base communications systems. Ensures planning and design are in concert with AF infrastructure.

3. <u>Application Reminders</u>

If you are currently assigned to a Special Duty Identifier (SDI) as outlined in the Air Force Enlisted Classification Directory (AFECD) it is your responsibility to submit an approved conditional release memorandum with your application from your career field manager/functional area manager stating you have fulfilled all obligations and will be released if selected for the position you are applying for. Failure to submit conditional release before listed closeout will result in disqualification from this announcement.

Promotion Opportunity: If this Military Vacancy Announcement is a promotion opportunity and you are currently assigned to a Special Duty Identifier (SDI), you must meet the promotion requirements as outlined in AFI 36-2502.

Applicants who are in a higher grade than the grade for this advertisement must provide a statement of understanding with your application stating you are willing to be voluntarily demoted without prejudice if selected for this position, IAW AFI 36-2502. If selected for this vacancy, voluntary demotion action must take place prior to being assessed to the Statutory Tour Program.

Pen/ink changes to any source document, i.e. Report on Individual Personnel (RIP), evaluations, etc. could result in disapproval.

4. About Statutory Tours

This is a fully funded Permanent Change of Station (PCS). Visit DFAS website for most current Basic Allowance Housing (BAH) & Basic Allowance Substance (BAS) rates for the duty location listed on this announcement.

All Members assigned to the Statutory Tour program will remain affiliated their state/territory while serving on Statutory Tour.

All field members to include AGR, Technicians & Drill Status Guardsmen must obtain State TAG approval with application submittal. Members currently assigned to the Statutory Tour program must obtain current director's approval.

Statutory Tour members may be eligible for the Post 9/11 GI Bill if they serve on active duty Title 10 and/or Title 32 502(f) AGR for 90 days or more, after 11 September 2001. Their eligibility percentage starts at 40% for 90 days to 5 months. It increases 10% every 6 months, maxing out at 100%.

Statutory Tour service time does not count toward reduced eligibility age for reserve retirement pay.

Further information regarding the Statutory Tour Program can be found in ANGI 36-6.

Application packages will be reviewed to ensure qualifications are met. Packages are reviewed within four duty-days of receipt.
