SUBJECT: Delegation of Authority to Approve the Meritorious Civilian Service Award

- 2. I hereby delegate the authority to approve the Meritorious Civilian Service Award as follows:
- a. The Commanders of Army Commands, Army Service Component Commands and Direct Reporting Units (DRUs); members of the Senior Executive Service serving as the Director of a DRU; and the Administrative Assistant to the Secretary of the Army for Headquarters, Department of the Army may approve the Meritorious Civilian Service Award, under the eligibility criteria and procedures set forth in reference 1b. For purposes of this delegation, the Principal Officials of the Headquarters, Department of the Army, their staffs and other elements, Field Operating Agencies, and Staff Support Agencies not specifically named as delegates of the prescribed authority fall under the purview of the Administrative Assistant to the Secretary of the Army.
 - b. This authority may not be further delegated.

- c. This delegation is effective immediately and remains in effect unless suspended, revoked or superseded.
- 3. This delegation modifies the approval authority for the Meritorious Civilian Service Award set forth in AR 672-20, paragraph 8-3 and Table 8-1 (reference 1b). The award approval authority established by this delegation will be incorporated in the next revision of reference 1b.

SUBJECT: Delegation of Authority – Awards Policy Establishment, Implementation and Oversight

1. References:

- a. 10 United States Code § 3016(b)(2), Assistant Secretaries of the Army.
- b. Department of Defense Manual 1348.33, Volume 3, Manual of Military Decorations and Awards: DoD-Wide Performance and Valor Awards; Foreign Awards; Military Awards to Foreign Personnel and U.S. Public Health Service Officers; and Miscellaneous Information, 23 November 2010.
- c. Army Regulation (AR) 600-8-22, *Military Awards*, 11 December 2006 (Rapid Action Revisions 15 September 2011 and 28 June 2013).
 - d. AR 672-20, Incentive Awards, 29 January 1999.
- 2. I hereby designate you to act on my behalf to establish, implement and oversee Army policy regarding military and civilian awards and delegate to you all authorities required to execute this responsibility.
- 3. As my designee for Army policy regarding military and civilian awards, you may delegate award approval authority to other Army officials, as you deem appropriate, unless expressly prohibited or restricted by law or Department of Defense policy, or as set forth herein. I reserve the authority to act on recommendations for award of the Medal of Honor and Distinguished Service Cross. No delegation or re-delegation of the authority conferred herein shall be effective unless it is in writing and determined not to be legally objectionable by the Office of the Army General Counsel.
- 4. Record copies of all delegations and re-delegations will be provided to the Office of the Administrative Assistant for archiving within 10 days of taking effect. I will hold you responsible and accountable for all actions taken pursuant to this delegation of authority or any subsequent re-delegation of authority.
- 5. This delegation will be incorporated in the next revision of AR 600-8-22.

SUBJECT: Delegation of Authority – Awards Policy Establishment, Implementation and Oversight

- 6. Although not a limitation on your authority to act in my behalf, when your proposed action or decision relating to the authorities and responsibilities conveyed by this delegation represents a change in precedent or policy; is of significant White House, Congressional, Department or public interest; or has been, or should be, of interest or concern to me, for any reason, you will brief me prior to the decision. Continue my practice of coordination with Office of the Army General Counsel.
- 7. This delegation is effective immediately and expires three years from the effective date, unless earlier suspended, revoked or superseded.

SUBJECT: Blanket Exception to AR 672-20, Incentive Awards – Approval Level for the Superior Civilian Service Award (SCSA)

1. References:

- a. AR 672-20, Incentive Awards, 29 January 1999.
- b. AR 600-8-22, Military Awards, 11 December 2006.
- 2. The purpose of this memorandum is to allow for a blanket exception to AR 672-20, section 8-4, and table 8-1. This exception will align the approval authority of the SCSA with that of the military equivalent Meritorious Service Medal (MSM). This exception will allow the Army to maintain parity in the recognition process for Soldiers and Army civilians.
- 3. AR 672-20, table 8-1, outlines the award approval levels and award alignment between the military and civilian services. Accordingly, the SCSA is the civilian equivalent to the military MSM.
- 4. AR 600-8-22, Military Awards, was revised to grant Brigadier General (BG) commanders and HQDA Principal Officials authority to award the MSM to U.S. Army personnel assigned or attached for duty to their command or organization. Previously that approval authority was with Major General commanders.
- 5. This blanket exception to AR 672-20, authorizing BG commanders and above (or civilian equivalent organizational heads) to approve the SCSA, will bring the civilian award approval levels back in alignment with that of the military awards.

1. References:

- b. Memorandum, DAPE-ZA, 18 Mar 09, Subject: Blanket Exception to AR 672-20, Incentive Awards Approval Level for the Superior Civilian Service Award.
- 2. Effective immediately, the following exceptions to AR 672-20, paragraphs 8-4, 8-5, and 8-6, as well as Table 8-1, have been approved: Principal Officials of HQDA may approve the Superior Civilian Service Award, the Commander's Award for Civilian Service, and the Achievement Medal for Civilian Service. Further, they may delegate in writing their approval authority for the Commander's Award for Civilian Service and the Achievement Medal for Civilian Service to General Officers and members of the Senior Executive Service within their respective organizations.

- c. Memorandum, DAPE-ZA, 18 Mar 09, subject: Blanket Exception to AR 672-20, Incentive Awards Approval Level for the Superior Civilian Service Award, hereby superseded.
- d. Memorandum, DAPE-ZA, 28 Mar 11, subject: Exception to Army Regulation (AR) 672-20, Incentive Awards Authority for Principal Officials of Headquarters, Department of the Army (HQDA), to Approve and Delegate Approval of Specified Civilian Awards.
- 2. The purpose of this memorandum is to authorize an exception to AR 672-20, section 8 and table 8-1. This exception will align the approval authority of the Meritorious Civilian Service Award (MCSA), the Superior Civilian Service Award (SCSA), the Commander's Award for Civilian Service (CACS), and the Achievement Medal for Civilian Service (AMCS) with the approval authority for comparable military awards.
- 3. The exception authorizes the following:
- a. Commanders, in the rank of Major General and above (or Civilian equivalent) may approve the Meritorious Civilian Service Award (MCSA), the Superior Civilian Service Award, the Commander's Award for Civilian Service, and the Achievement Medal for Civilian Service Award.
- b. Commanders in the rank of Brigadier General and above (or Civilian equivalent) and Principal Officials of HQDA, are authorized to approve the Superior Civilian Service Award, the Commander's Award for Civilian Service, and the Achievement Medal for Civilian Service Award.

SUBJECT: Exception to Army Regulation (AR) 672-20, Incentive Awards – Civilian Award Approval Levels

- c. Commanders, in the rank of Colonel and above (or Civilian equivalent) are authorized to approve the Commander's Award for Civilian Service, and the Achievement Medal for Civilian Service Award.
- d. Commanders, in the rank of Lieutenant Colonel and above (or Civilian equivalent) are authorized to approve the Achievement Medal for Civilian Service Award.
- e. Within HQDA, the provisions of DAPE-ZA Memorandum dated 28 Mar 11, subject: Exception to Army Regulation (AR) 672-20, Incentive Awards Authority for Principal Officials of Headquarters, Department of the Army (HQDA), to Approve and Delegate Approval of Specified Civilian Awards, remain in effect.
- f. Commanders, Lieutenant General and above, may delegate in writing their approval authority to General Officers and members of the Senior Executive Service within their respective organizations, in accordance with paragraphs 3. a d above.
- 4. This exception to AR 672-20 will bring the civilian award approval levels more in line with comparable military awards. It will thereby allow the Army to maintain parity in the recognition process of Soldiers and Army Civilians.
- 5. This exception supersedes the memorandum, dated 18 Mar 09, subject: Blanket Exception to AR 672-20, Incentive Awards Approval Level for the Superior Civilian Service Award (Reference 1c).
