PLAQUAMINES EOC CHAIRED BY AMANT (HOMELAND SECURITY DIRECTOR FOR PARISH) AND BENNY ROUSSELLE (PARISH PRESIDENT). IN ATTENDANCE AT THE MEETING WERE NUMEROUS USACE PERSONNEL, PARISH LEVEE DIRECTOR, USMC, AIR FORCE, ARMY AND AIR NATIONAL GUARD PERSONNEL. THE PARISH LEADERSHIPS

SOUNDNESS OF THE LEVEE SYSTEM. THE LEVEE REPAIR FAR EXCEEDS ANY TF AA CAPABILITIES BUT (B6) WILL TAKE LEAD IN GETTING THE USACE TO WORK A SOLUTION. APPARENTLY, DAMAGE OCCURRED TO THE INTERNAL STRUCTURE OF THE LEVEES. (B6) IS EXTREMELY CONCERNED WITH THE STATE OF THE LEVEES IN THE PARISH. THERE ARE IN EXCESS OF 20 BREACHES WITHIN THE LEVEE SYSTEM. SOME BREACHED AREAS ARE 20 FT IN DEPTH WITH GAPS OF 700 FEET IN LENGTH. THESE LEVEES PROVIDE PROTECTION TO SOME VERY CRITICAL INFRASTRUCTURE (NAVAL BASE, 3 X REFINERIES, FISHING & PORT ACCESS, MULTIPLE PIPLINE FACILITIES AND PUMPING FACILITIES) IN THE PARISH. (B6) STATED THE FOLLOWING IN RESPONSE TO (B6) REQUEST: THE USACE WILL TAKE LEAD OF THE PROBLEM IF OR WHEN DIRECTED. HE IDENTIFIED THE FOUR MAIN ISSUES IN ORDER TO REPAIR THE LEVEES IN A TIMELY AND EFFICIENT MANNER. 1. ACCESS TO THE EFFECTED AREAS. 2. MANPOWER NECESSARY TO CONDUCT REPAIRS 3. MATERIALS NEEDED TO REPAIR LEVEES 4. EXPERTISE (USACE WILL IDENTIFY AND BE ABLE TO RESOURCE THE PROPER EXPERTISE NEEDED). (B6) RECOMMENDED THE THREE PHASED RESPONSE TO THE IDENTIFIED PROBLEM SET. CG currently located in Lafayette. CP established in N.G. Armory at Airport.

Last night, slept on a cot in the Armory as Hurricane Rita made landfall so as to have immediate access to all communications platforms. Tonight, we were able to get him a room in the La Quinta Inn. The JCSE has relocated from the Convention Center in N.O. and set up their primary Comms package in the open bay of the Armory. In addition to supporting the Commander, they have been providing primary support to (B6). CDR 41st BDE, and to the Operations nodes from Cameron and Calcachieu parishes. An additional JCSE communications team was provided to the LA State Police yesterday in Lake Charles. Following passage of Hurricane Rita, the Lake Charles State Police encountered difficulty in communicating. CG directed 4-man JCSE element to remain in Lake Charles and provide State Police communication support. Also, at their request, CG directed that one LMTV remain to support the State

Police in Calcachieu Parrish with movement thru flooded city.

-Thru coordination with local Parrish Presidents, CG continues to facilitate onward movement of forces. TFAA focused initially on movement of elements into Lafayette. Following passage of Hurricane eye, (B6), DIVARTY CDR, moved from Lafayette N.G. Armory with Calcasieu Parrish President and (B6) and conducted recon of Lake Charles yesterday.

Divarty conducted movement of 400 man element forward to Lafayette. TFAA will conduct Search and Rescue south of Lafayette. Focusing on Lafayette Parrish south including Vermilion Parrish and Iberia Parrish...subsequently

moving west and north through Cameron and Calcasieu Parrishes. (B6)13th COSCOM, is to coordinate action and facilitate land management with BG Basilica, CDR 256 BDE, and with Lafayette Airport Manager,

(B6)82D will coordinate to stage buses at Lafayette Airport for onward movement

of evacuees. Air assets of TF Katrina will conduct Search and Rescue

operations in support of Hurricane Rita throughout the coastal areas south of Interstate 10 from Lafayette to Lake Charles....focusing initially on

Cameron and Vermilion Parrishes. (B6)has conducted air recon with N.G. UH-60....initial coordination conducted to facilitate TF Katrina utilization of Lafayette Airport for Rotary Wing Staging/operations. Continue specific coord with (B6), Airport Manager. Maritime assets facilitate Search and Rescue along coastal areas of Cameron and Vermilion Parrishes...to include Calcasieu Lake/river to Lake Charles. (B6), DIVARTY CDR (B6), DIVARTY
