

Contract Vehicle Options

For Environmental Projects

The objectives of the US Army Environmental Command Multiple Award Task Order Contracts (MATOCs) are to provide an acquisition alternative for acquiring performance based services to enhance traditional acquisition approaches and promote cost/performance efficiencies and considerations for environmental requirements throughout the Installation Management Command (IMCOM).

NOTE: For installations, there is no administration fee added to the cost of task orders on these contracts. USAEC has direct funded this cost for all Army users. This document serves as only a summary of the information included in the ordering guides for each MATOC.
