
#### Description

The Northern Wisconsin Environmental Infrastructure Assistance area includes the counties of Ashland, Bayfield, Douglas, and Iron. The program area includes a significant area of the shoreline of Lake Superior and the Upper Mississippi River watersheds. The program provides assistance to northern Wisconsin public entities in the form of design, construction and reconstruction assistance for water-related environmental infrastructure and resource protection and development projects, including projects for navigation and inland harbor improvement and expansion, wastewater treatment and related facilities, water supply and related facilities, environmental restoration, and surface water resource protection and development.

#### Status

Continuing design & construction efforts for existing projects. The Program was authorized at \$60M, with \$44M allocated to date. In Detroit District, there are still on-going projects in Hurley, Washburn, Bayfield, and on the Red Cliff Reservation. New Project Partnering Agreements (PPAs) may be executed to fully utilize funds received thus far, as excess project funds are consolidated from completed projects. A new PPA (Bayfield Catholic Hill) and a PPA amendment (Washburn) were executed in FY 15. One new PPA is expected in FY16. FY17 funds would be used to fund additional infrastructure projects.
