C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

A complete watershed review of the region centered on the project site was completed as part of this Approved Jurisdictional Determination. The following comments are a result of that review:

The area in question is a historical livestock pond situated on an ephemeral drainage with no bed or bank (grassy swale). The pond holds water due to a dirt berm on the downstream end with no outlet to the grassy swale, and has no evidence of interstate or foreign commerce such as recreational use, fish or shellfish harvesting, etc. It was determined that this pond is geographically isolated and not adjacent to any other waters of the US, does not have a nexus to interstate or foreign commerce, and therefore is non-jurisdictional under the Clean Water Act.
