

Initial Steps

STAKEHOLDERS identify the needs.

<u>SPONSORS</u> determine whether it may be eligible for federal assistance, request Corps to determine if there is a federal interest in pursuing project to address stakeholder needs, and work with the Corps and Stakeholders through the Federal process as a partner.

<u>CORPS</u> upon receipt of Congressional Authorization and funds, performs the Feasibility Study to determine if there is a Federal Interest.

Work with the Local Sponsor(s) through the Federal process as a partner.

Corps' Role

Upon receipt of Congressional Authorization and funds, performs Study to determine if there is a Federal Interest.

Work with the Local Sponsor(s) through the Federal process as a partner.

Enters into agreements with the Local Sponsor(s)

PED, PPA, MOA, Support Agreements

Enters into Contracts with A&E and construction firms to perform work not done in-house.

Administers the contracts.

Reviews design and construction for conformance to specifications.

Performs QA and site inspections.

Issues O&M manuals to Local Sponsor(s) upon completion of work and turnover to Local Sponsor(s).

Participates in stakeholder meetings.

Design – 65% Federal/35% Local

Construction - 65% Federal/35% Local

Operations & Maintenance – 100% Local
