- Primarily focused on Navigation Data Collection
 - ▶ Waterborne Commerce Statistics center (WCSC)

- Data collected: vessel trips and tonnages by commodity for ports and waterways
- Vessel operating companies must report domestic waterborne commercial movements to the Corps
- WCSC publishes summary statistics annually, working on CY 2015.
- ► Lock Performance Monitoring System (LPMS)
 - Real-time data collected at locks, focusing on time entries
 - Commodity and tonnage are estimates only
