Explain: **During review of the project area, several drainage features were noted on the property. All but one feature**

appeared perfectly linear on aerial images, with no sinuosity. Each drainage feature was reviewed during the site visits conducted in both August and February. While water was present in some of the features on the northern side of the property, there was no flow present downstream. Based on the vegetation and other hydrologic indicators, as well as the flooding systems, it was apparent that these drainage features were flooded periodically by artificial means to provide water for cattle raised on the property. In addition, a rise in the bank on the western side of the major northern drainage feature indicated that it was an upland man-made drainage ditch, created for the purpose of agriculture and other farming activities; therefore, these features are unnatural and maintained as drainage ditches. On the southern end of the property, another drainage feature was noted, which, during rain events, would convey hydrology off the property to an adjacent wetland. However, during both site visits, no water was present within the feature. Also, no ordinary high water mark, or hydrologic indicators of any kind, could be found within the channel. Although the channel was not as linear as other features on the property, it appears that this feature was created similarly to those, is dominated by the same vegetation, guinea grass (*Megathyrsus maximus*), and is an otherwise ephemeral feature. Based on these observations and the lack of evidence of a natural tributary, we have determined that all features within the project boundaries are upland man-made drainage ditches, and therefore, not subject to our jurisdiction under Section 10 of the Rivers and Harbors Act or Section 404 of the Clean Water Act. In addition, an area that appeared to have hydrology based on the aerial image provided by the applicant was examined as a potential wetland. However, during the site visit on 6 February, it was determined that this is an artificially inundated shallow pond. The dominant vegetation, though facultative, is sparse, and no other hydrophytic vegetation is present. In addition, the soils were not hydric. Therefore, based on the data points taken, a wetland is not present within the project boundaries.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
