### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The wetlands information submitted with Applicant's DA permit application includes a wetland delineation, dated 07 Feb 1997 by Char and Associates was determined invalid based on the info being +5 yrs old and is not in compliance with current wetlands guidance, which was issued in 2012 (Regional Supplement for the WDM). A site visit to verify

whether wetlands are still present was conducted on 12 Feb 2013, which determined the area previously delineated and labeled as "wetlands" on submitted plans were indeed absent of wetlands per the current applicable guidance.
