- 2. Up to 7 E9 selections to a compressed MCPO rating will increase associated E8 SCPO source rating quotas one-for one as per the following:

AVCM: up to 2 quotas from AECS or ATCS

CUCM: up to 3 quotas from BUCS, EACS or SWCS

UCCM: up to 2 quotas from CECS or UTCS

BUCS demand is -1 therefore if BUCS advances to CUCM no BUCS quota will be generated.

SWCS demand is -1 therefore if SWCS advances to CUCM no SWCS quota will be generated

CECS demand is -1 therefore if CECS advances to UCCM no CECS quota will be generated
