## **Craig D. Jensen**



### **Assistant General Counsel (EI&E) Office of the Assistant Secretary of the Navy**

Mr. Craig D. Jensen is the Assistant General Counsel (Energy, Installations & Environment). In this position, he directs the practice of law on behalf of the Department of the Navy in the fields of environmental, natural resources, real estate and energy law. As the Office of General Counsel's senior attorney for these legal issues, he is responsible for setting legal policy in those areas of practice throughout the Department of the Navy. Mr. Jensen has served in this position since April 2011.

Prior to his current position, Mr. Jensen served as Counsel for the Office of Naval Research, the Department of the Navy's center for science and technology programs, where he was the senior legal advisor to the Chief of Naval Research on a wide variety of legal issues relating to intellectual property, patents, trademarks, data rights, grants, procurement, the environment and personnel law. He was responsible for the management and supervision of a 30-attorney office.

Mr. Jensen has also served as the Deputy Counsel for the Commandant, United States Marine Corps, where he provided legal and business advice on the full spectrum of issues that face the Marine Corps, and supervised over 100 civilian and Judge Advocate attorneys and support staff located in a Headquarters office and 14 field offices throughout the world. In addition, Mr. Jensen was once the Navy's Special Counsel for Litigation, where he was responsible for the most important litigation matters under the cognizance of the General Counsel. He also supervised 30 attorneys who represented the Navy on significant cases brought before U.S. Federal Courts and the Armed Services Board of Contract Appeals. Mr. Jensen was appointed to this Senior Executive Service position in September 2006.

Mr. Jensen served on active duty in the Marine Corps, retiring at the rank of Lieutenant Colonel in 2003. For the four years preceding his retirement, Mr. Jensen held the billet of Associate Counsel, Land Use and Environmental Law, Office of the Counsel for the Commandant, where he provided environmental and installation law guidance to the Commandant and other senior Marine Corps clients. Upon retirement, Mr. Jensen was selected to retain this position as a civilian and held this position until his selection as Deputy Director of the Navy Litigation Office. In that capacity he supervised attorneys responsible for handling Navy litigation in contracts, environmental and civilian personnel law.

While on active duty in the Marine Corps, Mr. Jensen's legal responsibilities included tours of duty as a criminal prosecutor, a criminal defense attorney, and the regional environmental and land use attorney for Marine Corps installations on the east coast of the United States.

Mr. Jensen earned a bachelor's of arts degree from Gonzaga University in 1983, a juris doctor degree from George Washington University in 1991, and a master's of law degree in international environmental Law from the University of Washington in 1996. His awards include two Navy Distinguished Civilian Service Awards, the Navy Superior Civilian Service Award, the Office of the Secretary of Defense Award for Excellence, the Legion of Merit, the Meritorious Service Medal, the Navy Commendation Medal, the Navy Achievement Medal, and two Department of Justice Certificates of Commendation.
