RCAS PASSES THE TORCH

Mr. Dennis J. Lujan was introduced as the new Reserve Component Automation Systems (RCAS) Product Lead (PL), during an Assumption of Charter ceremony hosted by the Project Manager, Installation Information Infrastructure Communications and Capabilities (I3C2), Mr. Michael Padden on July 11, 2016, at Fort Belvoir, Virginia.

Mr. Lujan assumes his new position as the 11th RCAS PL after serving as the Division Director and Information Security Officer in the Office of Technology Solutions under the Office of the Chief Financial Officer for the Environmental Protection Agency. Mr. Lujan started his federal career in the U.S. Army in 1992 serving 20 years of active military service in operational and generating force units-resulting in an Honorable Discharge in 2012. Upon retiring, he continued his federal service as a civil servant with the Department of Veterans Affairs and most recently with the Environmental Protection Agency in Washington D.C.

During his service with the Department of Veterans Affairs, Mr. Lujan served as a Senior Program Manager overseeing corporate initiatives such as the Integrated Acquisition Program, Construction Management, Software Integration and Business Process Improvements. Mr. Lujan was later assigned to the Veterans Health Administration as the principle interagency liaison to a Joint Department of

Defense / VA integrated electronic health record program. He also served as a principal advisor to the interagency Clinical Informatics Board and provided executive oversight of all joint business requirement packages going to the board for executive decision.

Among Mr. Lujan's military decorations are the Defense Meritorious Service Medal, Meritorious Service Medal, Global War on Terror Expeditionary Medal and the NATO Medal.

Mr. Lujan is a graduate of the Command and General Staff Officer Course, holds a Masters Degree in Business Administration from the Florida Institute of Technology and a Masters in Criminal Justice Administration from Oklahoma City University.

RCAS ACTING PRODUCT LEAD

Greetings to everyone and thank you for your continued support to the RCAS organization and team. I am pleased to inform you that we are taking some innovative and transparent approaches in clearing our backlog of functional enhancements, with the support of our Prime Integrator and proactive work from the Software Sustainment Division. Our latest software release (7.0.14) delivers both new and improved application capability and functionality enhancements. The FY15 Product Refresh effort is in the final stages of implementation, and we are already preparing for the FY16 Product Refresh, the details of which will be shared with you by our Requirements Management Team in the coming weeks.

Since our last Requirements Control Board (RCB), RCAS made a huge step towards becoming a true enterprise instead of having multiple distinctly separate application access points between USARC and the 54 States and Territories of the ARNG. We worked with the Minnesota ARNG who developed a fully functional automated FLIPL (Financial Liability Investigation for Property Loss) tracking system, currently being used by multiple States, to make this an enterprise application within the RCAS suite of applications. The implementation of this enterprise application will streamline the current manual FLIPL process, provide tracking, and validation to reduce human error, resulting in actual savings to the USAR and ARNG. We are also implementing a centrally managed release installation support team, after discussion with the Data Processing Advisory Committee (DPAC) and multiple requests from the field.

As you will see in this newsletter, RCAS has a new Leader, Mr. Dennis Lujan, who assumed responsibility for the program on July 11, 2016. Mr. Lujan brings a wealth of knowledge and experience from the military and other federal agencies, and will lead the RCAS program to the next level.

Again – I thank YOU for all you do for our Soldiers and their families, as well as your interest in what our team is doing it is my honor to serve you...

RCAS RELEASE NEWS

RCAS Release 7.0.14 is deploying in July 2016, and the following is a recap of enhancements:

- The Mobilization Team is testing on Windows 10 running on Internet Explorer (IE) 11 on the pilot Army Gold Master (AGM) program. Archived Battle Rosters for the United States Army Reserve (USAR) will be able to use the old version of the Readiness Progress Review (RPR) Dialog and Reports.
- The Force Authorization Team successfully migrated all historical data to RCAS from Knowledge Online (GKO). Guard Attachments were not included in this migration; however, attachments will be accessible in Release 7.1.0. The team continues the conversion to Entity



Framework with the goal of eventually allowing for applications that are not dependent on any one type/brand of database. Certain elements of the underlying code for each application will be rewritten. The focus for this release is the Force Management application for the Guard.

- The Safety and Occupational Health (SOH) application was recently analyzed by the National Safety Center at Fort Rucker to possibly be an enterprise safety application for the entire Army, USAR and the National Guard (NG). RCAS is very hopeful we could be selected to share our Safety Manager's Tool with all of the Army! In addition, a tremendous effort has been completed in SOH to update 32 Master Inspection Checklists and map each checklist item to a Hazard Reference list. If you have a Master Checklist you would like to share with other States and Territories, please submit an Engineering Change Proposal (ECP) with a copy of the checklist. A copy of a blank ECP form is located on the RCAS Homepage located on AKO at: https:// www.us.army.mil/suite/page/207093, and click the Requirements Management folder.
- The Personnel Team has incorporated functionality of D02 Historical Load fielded scripts into the Retirement Points Accounting Management (RPAM) baseline and have exchanged retirement points data from RPAM to the Reserve Components Common Personnel Data System (RCCPDS). Also, several forms and reports will be migrated to the Unit Personnel System/Command Management System (UPS/CMS).

RCAS is upgrading to a new operating system on the Database server which has led to a new naming convention of releases going forward. The next RCAS release is Release 7.1.0 and is scheduled to deploy October 2016. The following enhancements along with other fixes and updates are included:

- The Mobilization Planning Data Viewer (MPDV) application will freeze the header that contains station names for Soldier Readiness Processing (SRP) which will make it easier for an administrator to assign operators to the correct station, especially if there is a large number of operators. With the Total Army Personnel Database-Reserve (TAPDB-R) replacing Regional Level Application Software (RLAS) for the USAR, Unit Mobilization, Alert Notification Roster, Soldier Contact Information will change to TAPDB-R so the statement "No Value in RLAS" will not populate anymore.
- SOH will include a change of the RAC 3 Description to Medium vice Moderate. There is also a Regulatory Verbiage Change for Contact Type values for an Off Duty person in Ground Accidents.
- The Force Authorization team added fillable/searchable drop-down boxes that when in Force Management (FM) under the Graphic Briefing Assistant (GBA) reports tab, a Plan will only display if it is locked and if the data type is either FM or Troop Support Program (TS).

Checks need to be sent to the RCAS Database Team at <u>USARMY</u> <u>Ft Belvoir PEO EIS List PDRCAS Database Team</u> prior to installation as well as post installation.



New installation videos are now available on Army Knowledge Online (AKO) https://www.us.army.mil/suite/files/46678026. The videos were created to assist RCAS Administrators with the installation process by walking the user through the installation steps. The videos go hand-inhand with the instructions in the RCAS Installation Guide (RIG). The RCAS Release 7.0.14 Post-Installation Town Hall will occur August 3, 2016. Your combined RCAS Requirements Management Team, consisting of government, program support and prime contractor staff, primary G6 staff members from the National Guard Bureau (NGB) with the States/Territories, and the U.S. Army Reserve Command (USARC), is prepared to again support you in any way we can to improve both your organizational and individual soldier operational capabilities.

This fiscal year's program acquisition objectives are focused to products and services which will continue the savings that you initiated beginning in FY14, and products that sustain your respective organizational infrastructures, deliver needed end user

devices to support your units and soldiers, and improve overall system security.

The system equipment and product requirement collection phase is now underway, which will be followed by product validation, consolidation and documentation of the total RCAS infrastructure. This total enterprise documentation of direct support information technology requirements provide the Product Office with accurate and acknowledged information that continues to be extremely important data for the formulation of the RCAS budget. RCAS AUTOMATED DEPLOYMENT

New RCAS File Share — PL RCAS is excited to announce a new RCAS File Share related to the evolving automated deployment initiative. Starting with RCAS Release 7.0.14, all RCAS releases will be posted to the new share location. The intent of this share is to allow administrators to access the share to retrieve RCAS release files directly from their local RCAS Web server versus having to rely on SCCM administrators at the National Guard Bureau (NGB) to copy files down to the site locations.

To implement the new process, it's important for RCAS sites to verify that local firewall ports are open for future deployment of RCAS releases by way of the new PL RCAS

managed share folder. The new share folder is located at the following GuardNet location:

If a site cannot access the new file share they will need to submit an activation request through the standard Firewall Port Activation (FPA) process. Refer to the FPA Technical Bulletin issued on July 1, 2016 for more details on the FPA process.

RCAS "BOARD OF DIRECTORS" CONVENE FOR APRIL MEETING

Acting RCAS Product Lead, Mr. Saj George, hosted the second of this fiscal year's Biannual Requirements Control Board (RCB) meetings on Thursday, April 21, 2016, at the United Services Organization (USO) Warrior and Family Center, Fort Belvoir, VA. Mr. George welcomed all of the board members and guests, and reinforced the board's focus to identify and discuss program and system requirements, emphasizing the need for an interactive and open dialogue. He introduced Mr. Michael Padden, Project Manager, Installation Information Infrastructure — Communications and Capabilities (I3C2), who provided a brief summary of the recent PEO EIS revised management structure, describing the new organizational relationship between I3C2 and RCAS. I3C2 internal program updates were also presented to introduce the RCAS board members and guests to the current organization roles and responsibilities.

RCAS program management updates were presented, including the current budgetary summary provided to Government-only attendees by the Business Management Division. This was followed by update presentations from the Technical Management, Software Sustainment, Application Training, and Requirements Management program leadership staff.

Stakeholder updates were presented by the respective ARNG/USAR functional representatives relating to the RCAS Testing Process by ARNG G1 Personnel Systems; State Application Development Updates/Concerns by the United States Property and Fiscal Office (USPFO) Data Processing Advisory Committee; Station Plan Submission Application – A Success Story by the ARNG G3 Force Management; Distributed Learning Program Support Update by ARNG G3 Training Division and USAR/USACAPOC/MILCON & IT Modernization by the USARC.

Strategic initiative updates were provided by the ARNG G6 and USAR CIO/G6 leadership teams, both highlighting current organizational structures and respective responsibilities. The USPFO Data Processing Advisory Committee representative communicated the desire for the State Data Processing Managers

to assist in implementing a capability to access information from a central data base. The RCAS Acting Product Lead presented the RCAS Technology Roadmap as the business framework for both developing and implementing the 2025 Vision, and provided highlights and timelines for the Draft 100 and 500 day plans.

The Requirements Management Team continues to address the key actions identified during the meeting as well as the adjustments necessary to continue to transition this important forum to a more interactive, strategic planning organization.

ATTENTION ALL VEEAM USERS!

Veeam® Availability Suite™ combines industry leading backup, restore and replication capabilities to the RCAS with advanced monitoring, reporting and capacity planning functionality. The Veeam® Availability Suite™ delivers what the RCAS needs to reliably protect and manage VMware vSphere environments.

Veeam v8 has been successfully tested against the RCAS baseline. Based on that assessment, it is highly recommended that sites utilizing Veeam v7 as the RCAS backup solution upgrade as soon as possible to Veeam v8 because v7 is no longer supported. RCAS purchased enough licenses to cover a four-core processing environment for each site previously using Veeam. Sites are prohibited from expanding beyond the core limit so that license compliance can be maintained. To obtain the software for Veeam v8, it will be necessary to create an account at the Veeam website



at http://www.veeam.com. Once you have created an account, you will be able to download the software.

A Certificate of Networthiness (CON) for Veeam 9 has been submitted to NETCOM for approval. RCAS will keep you posted on any

updates. The USARC Designated Approving Authority (DAA) granted interim approval for use in the Unified Computing System (UCS) environment at Fort Bragg for 180 days. All other users, including the ARNG, must wait for Army-wide CON approval.

THE DISTRIBUTED LEARNING PROGRAM—2016 PROGRESS

The Army National Guard (ARNG) Distributed Learning (DL) Program creates content for Guard-specific training requirements, provides access to the content through GuardU (an online learning portal), and enables delivery through a nationwide network of 379 ARNG DL Classrooms. PL RCAS supports the ARNG DL Program as the fielding office for the ARNG DL Classrooms, providing workstation and audio/video equipment refresh, modernization fielding, sustainment services, and technical support to the

State DL Program Administrators and the State DL Classroom Administrators.

The Training Support Branch (ARNG-TRS), Training Division, ARNG G-3 manages the ARNG DL Program, and their vision is to "take the classroom to the Soldier, not the Soldier to the classroom." PL RCAS and ARNG-TRS have collaborated since

2007 to modernize the DL Classrooms into a mix of legacy Fixed DL Classrooms (FDLCs) and Mobile DL Classrooms (MDLCs), providing the States with a capability to quickly relocate DL "points of delivery" to the training point of need, at or near unit home stations.

During the first half of 2016, PL RCAS fielded 49 AV800 FDLC audio/video system upgrades, 17 new MDLCs, and shipped more than 1,600 refreshed workstations nationwide. DL Classroom

system upgrades and additions will continue through 2016 with 53 sites receiving new equipment.

RCAS CONTINUES MULTI-COMPONENT JAC SUPPORT

The RCAS Mobilization Planning Data Viewer (MPDV) team continues to support the Multi-Component Joint Assessment Conferences (JACs) at Fort Leavenworth, Kansas, with the last support event occurring 9 thru 12 May 2016. Mr. Max Dunn, the MPDV Product Owner, assisted by Mr. Dan Costner, who provides U.S. Army National Guard (ARNG) and U.S. Army Reserve (USAR) Liaison support for RCAS, provided support as enablers

RCAS, provided support as enablers at this very important conference. Enablers provide specific information and support to those units deploying soon and the RCAS enabler station is required for all USAR units. The MPDV team provides current information on the use of MPDV during the mobilization process, from building Battle Rosters for all USAR units thru Soldier Readiness Processing (SRP) event planning. Also included is information on the required submission of the unit's mobilization data at the appropriate times from MPDV to the Department of the Army Deployment and Reconstitution Tracking Software (DARTS) system, which provides this critical data to the mobilization stations. The MPDV team also provides

training and RCAS access administrator contact information as

needed. The RCAS MPDV team met with all USAR units in attendance at the May 2016 JAC and many ARNG units as well.

RCAS support as enablers was also made available to all ARNG units in attendance. The RCAS station is not a required station for ARNG units. The ARNG does not require the use of MPDV for building their Deployment Manning Document but many units still use the SRP support

module of MPDV. Both ARNG and USAR units must still use MPDV for submission of soldier readiness data to DARTS. Many ARNG units and soldiers stopped by the RCAS station asking questions and receiving updates on MPDV.

The RCAS MPDV team plans on providing support to the next Multi-Component JAC scheduled in August 2016 at Fort Leavenworth.

RCAS SRP SUPPORT CONTINUES

The RCAS Mobilization Planning Data Viewer (MPDV) Team continues to support Soldier Readiness Processing (SRP) events. This past April, Mr. Max Dunn, the RCAS MPDV Product Owner, supported an event for the 314th Press Camp Headquarters (PCH) at the U.S. Army Reserve (USAR) Center located at Fort Jackson, SC, on 15 and 16 April 2016. The event was a combined SRP consisting of Soldiers who are deploying as well as those receiving a comprehensive medical review to ensure current immunizations, dental examinations and hearing check data is recorded in MPDV. During this SRP event each Soldier had the opportunity to discuss any medical issues or concerns with a surgeon.

The event, conducted by the 99th Regional Support Command (RSC) for the 314th PCH, processed over 100 Soldiers during the two day period. Soldiers were checked into the event and its various processing stations using a Soldier's Common Access Card (CAC) which automatically pulls up the Soldiers information in MPDV. This saves valuable time and makes the process easier and much faster.

The support provided had a very positive impact on the unit's ability to capture accurate Soldier Readiness data into the enterprise web-based MPDV application. Unit leadership expressed their satisfaction with the immediate soldier visibility and control that MPDV provided throughout the SRP process.

To assist unit personnel, unit administrators and commanders with the use of this time-saving MPDV tool, RCAS offers MPDV Leadership Workshops, briefings and SRP support for all levels of command. This support is fully funded by RCAS so there is no cost to the field.
