ALL QUALIFICATION RECOMMENDATION LETTERS NEED TO BE SUBMITTED TO OPNAV N2/N6, POC LT KWASI SNEED (kwasi.sneed@navy.mil), BY 10 AUGUST 2015. QUALIFICATION LETTERS RECEIVED AFTER 10 AUGUST WILL BE REVIEWED

BY THE PRESIDENT OF THE BOARD ON A CASE BY CASE BASIS TO DETERMINE ELIGIBILITY FOR THE COMMAND PANELS.

ONLY ELIGIBLE OFFICERS MAY COMMUNICATE WITH AN ADMINISTRATIVE BOARD. WRITTEN COMMUNICATION MUST BE IN ACCORDANCE WITH MILPERSMAN 1420-010 AND MAY INCLUDE, AS ENCLOSURES, CORRESPONDENCE FROM ANY INDIVIDUAL CONCERNING THE ELIGIBLE OFFICER. CORRESPONDENCE NOT ORIGINATED BY THE ELIGIBLE OFFICER, INCLUDING ENDORSEMENTS TO THE OFFICERS LETTER, AND LETTERS WRITTEN ON BEHALF OF THAT OFFICER MUST CONTAIN A WRITTEN ACKNOWLEDGEMENT BY THE ELIGIBLE OFFICER THAT HE OR SHE DESIRES THAT SUCH CORRESPONDENCE BE PRESENTED TO THE BOARD. CORRESPONDENCE WITHOUT SUCH ACKNOWLEDGEMENT IS CONSIDERED THIRD PARTY CORRESPONDENCE AND WILL BE RETURNED. CLASSIFIED CORRESPONDENCE WILL NOT BE ACCEPTED. NAVY PERSONNEL COMMAND MEMBERS (DETAILERS, ETC.) ARE SPECIFICALLY PROHIBITED FROM DELIVERING CORRESPONDENCE TO THE BOARD. OFFICERS DESIRING TO BE REMOVED FROM CONSIDERATION MAY INCLUDE IN THEIR STATEMENTS THEIR REASONS FOR DOING SO, IF DESIRED.
