Quarterly List of Compressed Gas Cylinders and Fire Extinguishers

1. COMPRESSED GAS CYLINDERS

Gas Cylinders can be ordered through Supply under the following stock numbers:

Oxygen (240 CF = 1 ea)	NSN 8120-00-357-7992

Units needing compressed gas cylinders refilled should contact a local vendor to coordinate refill of the cylinder and use their credit card for payment.

LRC- Fort Sill Maintenance Division technically inspects unserviceable cylinders for serviceability by using DA Form 2407. After inspection customers will take the 2407 and turn-in document to LRC-Fort Sill Supply using normal supply procedures.
