He ensures that operational actions are completed in accordance with policies and procedural requirements. He personally developed the tasker database that is utilized by all command personnel.

Mr. Jackson is committed to excellence and consistently the model of professionalism. He manages and mentors subordinates, and is sought after by peers in the WCTP, WTUs, RMCs, and by WTU leadership for his knowledge of the program, his continuity and history. Mr. Jackson demonstrates commitment to excellence in service and assistance to the Soldiers, Families, Cadre, Leaders, and Civilians in the Army Warrior Transition Command and Warrior Care and Transition Program.

OPORDS, WARNOs are done well in advance of the deadline, and maintains that the command has updated current operations information at all times.

Nominations for the WTC Civilian Employee of the year are submitted by Division Chiefs and nominations are reviewed by the WTC Civilian Employee of the Year Award Selection Board that consists of a Chair and representatives from each division and directorate.
