- 4. EFFECTIVE 31 MAR 2015, THE MDTP WILL TRANSITION FROM USING THE SOLDIER'S SOCIAL SECURITY NUMBER (SSN) TO THE DEPARTMENT OF DEFENSE EDI-PI LOCATED ON THE BACK OF THE COMMON ACCESS CARD (CAC).
- 4.A. AR 600-85, CHAPTER 4, PARAGRAPHS 11-13 AND APPENDIX E, PARAGRAPHS 1-13 OUTLINES THE MILITARY DRUG TESTING COLLECTION PROCEDURES THAT THE EDI-PI WILL SERVE AS THE PRIMARY MEANS FOR SOLDIER AND SAMPLE IDENTIFICATION.
- 4.B. DRUG TESTING PROGRAM CLIENT COLLECTION SOFTWARE (DTP-CCS) IS UPDATED TO ACCEPT THE EDI-PI AND CAN BE DOWNLOADED FROM THE ARMY

  HTTPS://EMILPO.AHRS.ARMY.MIL/ SELECT: AHRS ENTERPRISE DATASTORE. ON THE PUBLIC FOLDER TAB, NAVIGATE TO: PUBLIC FOLDERS > HRC >TAGD THE ADJUTANT GENERAL DIRECTORATE > DTP DRUG TESTING PROGRAM. RUN THE "DTP ROSTER" QUERY. THE QUERY WILL PROMPT USERS TO ENTER A UIC. ENTER THE UIC IN ALL CAPS (INCLUDING THE "W") IN THE LEFT PROMPT WINDOW. CLICK ON INSERT TO MOVE THE UIC TO THE RIGHT WINDOW THEN CLICK FINISH. USERS CAN SAVE THE RESULTS AS AN EXCEL 2007 FILE.
- 4.D. BOTH THE SSN AND EDI-PI WILL BE ACCEPTED AT THE DRUG TESTING LABORATORIES DURING THE TRANSITION. A DATE THE SSN WILL NO LONGER BE ACCEPTED FOR THE MDTP WILL BE ANNOUNCED BY DOD IN FUTURE CORRESPONDENCE.
