Significance

Every person and vehicle entering restricted areas is subject to search.

- Unauthorized entry is prohibited.
- Photographing, making notes, drawings, maps, or graphic representations of these areas or their activities is prohibited unless specifically authorized by the Commander.
- Any such materials found in the possession of unauthorized personnel are confiscated.
