FIREWOOD LICENSE
(QMCENFL Suppl 1 to AR 405-90)

AUTHORITY: 10 USC 3012.

PRINCIPAL PURPOSES: To allow the holder of the Firewood License to remove firewood from the installation.

ROUTINE USES: To verify the name of the license holder against the name on the license and to contact the individual when the license has been processed.

MANDATORY OR VOLUNTARY DISCLOSE AND EFFECT ON INDIVIDUAL NOT PROVIDING INFORMATION:
Voluntary disclosure. If the information is not provided, the individual cannot be issued the license.

1. The following individual is authorized per AR 405-90, Disposal of Real Estate, 10 May 95, to remove (as many within timeframe issued) loads of firewood for **30 days** from the time of issue:

2. Requirements are as follows:

- a. Cost of firewood is _____ for each load removed from the installation.
- b. A load is any amount up to but not exceeding one-half cord (approximately 1,000 pounds). One-half cord is a pile of wood 8 feet long, 2 feet wide and 4 feet high.
- c. The buyer will supply all equipment and labor.
- d. Wood will be cut only in area(s) and designated at times:

- e. All wood must be cut at one of the above collection sites. Failure to adhere will immediately suspend cutting privileges.
- f. Trash and refuse will not be deposited on the installation.
- g. Individuals not following the above requirements will not receive additional firewood permits.
- h. No minors will be allowed on work-site.

i. The undersigned does hereby, and as an inducement to the military authorities to grant a permit to remove wood from Fort Lee, forever release, acquit, and discharge, the United States of America, the United States Army, all officers, organizations, military and civilian personnel, and activities of the United States or the United States Army, and any other individual or organization connected with the United States or the United States Army from any and all cause or causes of action, including personal injury, illness, death, property damage, costs, charges, claims, demands, and liabilities of whatever kind, name or nature in any manner arising out of the use or enjoyment of said permit or any control exercised over said use, participation, property facilities, equipment, or individual involved in the use or enjoyment of any permit.

j. This release is intended to cover all injuries fatal or nonfatal, and illnesses of every name, kind or nature, and personal property damage, if any, which may be or might be sustained or suffered from any cause whatsoever connected or arising out of or by reason of the use of or participation in, or involvement with military facilities, equipment, services, or programs.

k. The undersigned further agrees to indemnify and will hold harmless the United States of America, the United States Army, and all organizations, activities, and personnel of the United States or the United States Army from any and all costs, charges, claims, demands, and liabilities of any kind arising from improper or negligent use of, participation in, or involvement with military property, facilities, equipment, services, or programs.

l. It is clearly understood that the function of the military and military or civilian personnel of the military is limited solely to the granting of permits.

m. I have received a Safety Alert about the safety precautions for use of a chain saw and a map showing the designated areas that I am authorized to cut and remove wood.

3. I further understood that:

a. No safety inspections necessarily have been or will be made of the areas in which wood will be removed.

b. No efforts necessarily have been or will be made to identify natural or man-made hazards in the areas in which wood will be removed.

c. No efforts necessarily has been or will be made to ascertain the qualifications of any license to use any type of equipment, including but not limited to hatchets, axes, saws, power or chain saws, and motor vehicles. Some licensees may be using these or other types of equipment.

d. The military or its personnel will necessarily exercise no control over the activities of licensees. Some licensees may be engaged in cutting down standing timber.

e. The above list is not exhaustive and the military and its personnel will not be required to either take or refrain from taking any action to warn licensees or provide for the safety of licensees or other individuals, regardless of whether such action is reasonable under the circumstances.

f. The license fee is not intended to generate any revenue for the Government, but merely pays for the cost of administering the license program.

g. A "licensee" is any individual who has been granted a permit or otherwise given permission to remove wood from any other location at Fort Lee.
